## NOTICE OF PUBLIC HEARING

### PROPOSED SETTLEMENT AGREEMENT AND STIPULATION FOR ENTRY OF ADMINISTRATIVE CIVIL LIABILITY ORDER R7-2021-0006

IMPERIAL IRRIGATION DISTRICT, OWNER/OPERATOR

**NOTICE IS HEREBY GIVEN THAT** the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public comment a proposed resolution of discharge limit violations subject to mandatory minimum penalties pursuant to California Water Code (Water Code) section 13385, subdivisions (h) and (i).

On July 22, 2021, the Assistant Executive Officer of the Colorado River Basin Water Board signed proposed Settlement Agreement and Stipulation for Entry of Administrative Civil Liability Order No. R7-2021-0006 (Stipulated Order) to Imperial Irrigation District (Discharger), Owner/Operator of the El Centro Generating Station and Grass Carp Hatchery, to resolve effluent limit violations of Waste Discharge Requirements (WDR) Orders R7-2009-0020, R7-2014-0005 (NPDES No. CA0104248), R7-2010-0023 and R7-2016-0003 (NPDES No. CA7000004) without a formal enforcement proceeding.

The Discharger and Colorado River Basin Water Board Prosecution Team (collectively, Parties) have entered into a tentative settlement to resolve the violations alleged in the proposed Stipulated Order. As a result, the Parties have agreed to settle the matter and intend to recommend to the Colorado River Basin Water Board at the September Board Meeting, that it adopt the proposed Stipulated Order under Water Code section 13323 and Government Code section 11415.60. The Prosecution Team believes that the resolution of the alleged violations is fair and reasonable and fulfills the Prosecution Team's enforcement objectives, that no further action is warranted concerning the specific violations, and that the proposed Stipulated Order is in the public's best interest.

Accordingly, to resolve the alleged violations by consent and without further administrative proceedings, the Parties have agreed to the final imposition of an administrative civil liability against the Discharger in the amount of **\$549,000**. The Parties have further agreed that **\$549,000** will be suspended pending the Discharger's completion of a Supplemental Environmental Project (SEP). Additional details concerning this proposed settlement are described in the proposed Stipulated Order. **The settlement is contingent on Colorado River Basin Water Board approval.**

If no significant comments are received in opposition to the settlement within the 30-day comment period and no new material facts become available to the Colorado River Basin Water Board, the proposed Stipulated Order will be presented to the Board and its Executive Officer for approval.
