The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0016 (Proposed Order) to the Metropolitan Water District of Southern California (Permittee) for the Colorado River Aqueduct Conduit Structural Protection Project (Project). The Project site is located near the cities of Desert Hot Springs and Indio, unincorporated communities of Sky Valley and Chiriaco Summit, and unincorporated Riverside County, California. The Project is expected to impact waters of the state.
