**NOTICE OF PUBLIC HEARING

WASTE DISCHARGE REQUIREMENTS
PROPOSED ORDER R7-2021-0040**

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) has prepared proposed Order R7-2021-0040 (Proposed Order) for the Coachella Valley Aggregates Wash and Screening Plant and Inert Waste Debris Engineered Fill Operation (Facility), owned and operated by Coachella Valley Aggregates, Inc., located in Indio, Riverside County. The Regional Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
