Staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) have prepared tentative Waste Discharge Requirements (Tentative WDRs) R7-2022-0041 for Chiriaco Summit Water District's proposed water system improvement project to be located approximately 0.2 miles north of the community of Chiriaco Summit, Riverside County, California 92201. The Regional Water Board intends to consider adopting the Tentative WDRs during a public hearing that will commence at the following date and time:

Interested persons are invited to attend and express their views orally on this matter at the public hearing. The Regional Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.

Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. Comments from the public will be limited to three (3) minutes per person. Any person planning to make a presentation to the Regional Water Board that requires the use of visual aids (such as slides, or video) should contact the assigned staff person to make arrangements before the meeting date in order to avoid unnecessary delays during the meeting. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive.
