BACKGROUND

Water Quality Control Plan (Basin Plan) for the Colorado River Basin is the guiding document that outlines the Colorado River Basin Water Board's plan for preserving and enhancing water quality in the region for the protection of beneficial uses for present and future generations. The Basin Plan contains the region's beneficial uses for groundwaters and surface waters, water quality objectives (WQOs) for protection of beneficial uses, and implementation programs to achieve WQOs.

The proposed Basin Plan Amendment was developed in response to the State Water Resources Control Board's (State Water Board) adoption of Tribal Beneficial Uses and Statewide Mercury Provisions. Tribal Beneficial Use definitions are a group of beneficial uses that can help protect activities specific to Native American cultures and their uses of California waters, including the consumption of non-commercial fish or shellfish. Tribal Beneficial Use definitions can also be referred to as cultural uses of water.

The Project will involve incorporation of an existing State Water Board definitions for "Tribal Beneficial Uses," as well as certain administrative updates, specifically:

- (1) Inclusion of Statewide Mercury Objectives to the Water Quality Objectives in Chapter 2 of the Basin Plan.
- (2) Formally incorporate the Human Right to Water in Policies (see Water Code, § 106.5) in Chapter 5; and
- (3) Update Salton Sea information included in Chapters 1 and 5 in response to public comments (e.g., revising Salton Sea language to reflect current restoration plans and other pertinent information).
