### PUBLIC HEARING NOTICE

**THE CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD, LAHONTAN REGION  
WILL HOLD A HEARING AND CONSIDER ADOPTING AMENDMENTS TO THE WATER  
QUALITY CONTROL PLAN FOR THE LAHONTAN REGION TO REMOVE THE

**NOTICE IS HEREBY GIVEN** that the California Regional Water Quality Control Board, Lahontan Region (Water Board) will hold a public hearing to receive comments on the Water Quality Control Plan (Basin Plan) amendments to remove the prohibition on new pier construction in fish spawning habitat at Lake Tahoe. The Water Board has prepared draft Basin Plan amendments and a draft staff report, including substituted environmental document.
