

DoCo-1: NDEP understands the County does not retain authority over the GIDs and therefore cannot require GIDs to implement load reduction measures within their jurisdictions. Admittedly, the complex governmental composition of the Tahoe Douglas region will necessitate a greater degree of collaboration and cooperation to implement the TMDL. Although there may be multiple alternative approaches to resolving this issue, NDEP believes that Douglas County should take the lead on implementing the TMDL. The primary reasons are provided in Section 11.2.4 of the Lake Tahoe TMDL Report. This does not mean that the GIDs do not have a role in TMDL implementation. However, the level of responsibility will likely vary between individual GIDs, and NDEP encourages the County to work with each GID to determine the appropriate roles and responsibilities. NDEP is committed to assisting in this process to the extent possible.
