POSTPONEMENT OF BOARD CONSIDERATION FOR ADOPTION OF TENTATIVE WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT FOR CITY OF REDONDO BEACH, SEASIDE LAGOON, REDONDO BEACH (NPDES NO. CA0064297; CI NO. 8034)

Our letter dated December 7, 2016, informed you that consideration of the tentative Waste Discharge Requirements (WDRs) and National Pollutant Discharge Elimination System (NPDES) permit for the subject facility would be heard during the March 2, 2017, Board Hearing. On January 27, 2017, Regional Water Board staff received comments from the City of Redondo Beach and from Heal the Bay regarding the tentative WDRs. The City of Redondo Beach also requested a compliance schedule in a Time Schedule Order (TSO) for metals to provide time to evaluate and implement options to comply with the new effluent limitations. Additional time is also required for Regional Water Board staff to consider the comments, incorporate any changes into the WDRs, and to prepare a TSO for Regional Board consideration.

Therefore, consideration of the tentative WDRs and NPDES permit has been postponed to a future Board Hearing. We will advise you accordingly of the new Board Hearing date and location. If you have any questions, please contact Mazhar Ali at (213) 576-6652.
