REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT AND RESPONSE TO COMMENTS FOR JOINT OUTFALL SYSTEM, POMONA WATER RECLAMATION PLANT (NPDES NO. CA0053619, CI-0755)

We have revised the tentative WDRs and NPDES permit dated September 10, 2014, based on comments received by the October 10, 2014, public comment deadline. A copy of the revised tentative Order and written responses to all comments received are enclosed. Changes to the tentative WDRs appear in strikeout and underline format. Written comments are not being solicited regarding the revised tentative Order.

In accordance with administrative procedures, the Los Angeles Regional Water Board at a public hearing to be held on **November 6, 2014, at 9:00 a.m., at the Metropolitan Water District of Southern California Board Room, 700 North Alameda Street, Los Angeles, California**, will consider the enclosed revised tentative requirements and comments submitted in writing regarding the revised tentative Order. The Board will hear any testimony pertinent to this revised tentative Order. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff.
