**TENTATIVE AMENDED TIME SCHEDULE ORDER (TSO) NO. R4-2013-0026-AX
REQUIRING CHEVRON PRODUCTS COMPANY, EL SEGUNDO REFINERY TO COMPLY
WITH REQUIREMENTS PRESCRIBED IN ORDER NO. R4-2013-0025 – CHEVRON
PRODUCTS COMPANY, EL SEGUNDO REFINERY, EL SEGUNDO, CALIFORNIA (NPDES
NO. CA 0000337, CI NO. 1603)**

Dear Ms. Worley:

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) has reviewed the "Request for Compliance Schedule Extension for Acute Toxicity Time Schedule Order" submitted by Chevron Products Company (Discharger) on February 1, 2016, which included an update on progress made to complete the tasks required as per TSO No. R4-2013-0026. The request indicated that after the selection and design of a treatment system, an unanticipated additional task of obtaining a South Coast Air Quality Management District (SCAQMD) Permit to Construct was identified. The process of obtaining the SCAQMD permit takes from twelve to twenty-four months to complete. Construction of the treatment system cannot begin until the SCAQMD permit is obtained. Hence, the TSO requires modification to update the tasks and schedule.

The enclosed tentative TSO amendment No. R4-2013-0026-AX includes the new tasks and schedule required to achieve compliance with the final effluent limitations contained in Order No. R4-2013-0025. The TSO amendment provides a limited eight-month extension that terminates on the same day as the associated permit, Order No. R4-2013-0025. In the event that the activities are not completed during the term of the TSO amendment, the Discharger may make a request to the Regional Water Board for an amended or new TSO and provide the required information to support the request.

Also enclosed is the Notice of Proposed Issuance of TSO No. R4-2013-0026-AX. As indicated in the Notice, the Executive Officer, pursuant to his delegated authority from the Regional Water Board, intends to issue the TSO amendment without a public hearing. Written comments must be submitted by **5:00 p.m. on October 14, 2016** and in accordance with the procedures provided in the Notice. The Regional Water Board will neither consider nor respond to untimely written comments.
