Chair Camacho called the meeting to order at 9:00 a.m.

She explained the process for participation in the virtual meeting, noting that for those who only want to listen or watch the meeting, the Board's customary webcast was available, and that the Board has Spanish translation services available through the Zoom platform for those who want to listen or participate in the meeting in Spanish. She provided instructions on how to join the Zoom meeting for those wishing to provide comments on an agenda item, and she announced that the meeting was being recorded.

Sergio Morales, one of the Spanish translators, provided instructions on how to participate in the meeting in Spanish.

Item 3 – Approval of Draft Meeting Minutes for the February 23, 2023, meeting.

Item 4 - Board Member Communications

a. Ex Parte Disclosures (Board members identified any discussions they had requiring disclosure pursuant to Government Code section 11430.40.)

Chair Camacho reported on one ex parte communication.

On March 13, 2023, she received an email with a letter attached from Mr. Ray Tahir. She understood that the letter was a prohibited ex parte communication because it related to the pending NPDES permit for the Tesoro Refining & Marketing Company and mentioned the odors associated with the Dominguez Channel. She did not read the letter. She forwarded the email to the acting executive officers and legal counsel.

Board Member Méndez reported on two communications.

He received the same ex parte email with the attached letter from Mr. Tahir. He did not read the letter. He deleted the email.

He has communicated with LA Waterkeeper and Alliance for a Better Community on school greening projects. He discussed green spaces and other types of groundwater capture opportunities, particularly in low-income communities of color in the Los Angeles Unified School District and throughout LA County.

Board Member Muñoz reported on one ex parte communication.

She received the same letter from Mr. Tahir. She did not open the letter.

Board Member Stahl reported on one ex parte communication.

He received the same letter from Mr. Tahir and a letter regarding zinc. He forwarded both letters to Regional Water Board staff.

Board Member Christiansen reported on one ex parte communication.

She received the same letter from Mr. Tahir. She did not read the letter.

Board Member Ashjian reported on three communications.

She received the same ex parte email with an attached letter from Mr. Tahir. She did not read the letter.

She had a discussion with LA Waterkeeper and Heal the Bay. She did not discuss any pending matters.

She received an email from the Farm Bureau in Ventura County inviting the Board to participate in a tour of the farms.

b. Board Member Reports:

Board Member Méndez reported that he is involved with two different water related issues statewide. The issues review the disproportionate amount of infrastructure and resources, particularly flooding issues and other types of climate resilience projects, in low-income agricultural farm worker communities.

Board Member Muñoz reported that she received a call from James Simonelli, Executive Officer with the California Metals Coalition. Mr. Simonelli invited her to their 50th anniversary.

Board Member Christiansen reported that she hosted a conference on weather whiplash with funders in both California and outside of California that are either directly connected or tangentially connected to our water supply issues. Speakers for this event were: Pablo Garza, California State Assembly, Ellen Hick, Public Policy Institute of California, and Liz Crossen, Metropolitan Water District.

Board Member Ashjian reported that March 22, 2023, was World Water Day and the theme was accelerating change to solve the water and sanitation crisis.

Item 5 – Executive Officer's Report

Hugh Marley, Acting Executive Officer, provided updates on the following items: preparation for a proposed Ballona Wetlands tour and May 2023 Information Item: development of Waste Discharge Requirements for irrigated agricultural operations; participation in the Clean Water State Revolving Fund Policy and Intended Use Plan update meeting; progress on cleanup of the former Kast Property Tank Farm, updates on the Ojai Valley Sanitary District sewage spill that occurred on January 23, 2023, and the March 16, 2023, sewage spill in Fillmore; preparation for implementation of the Reissued Stormwater Construction General Permit with new requirements becoming effective on September 1, 2023; and updates on enforcement items, including issuance of a \$1.22 million administrative civil liability complaint against Robert French and Wahib Mikhail, the owners and operators of Buy Rite Gasoline on December 27, 2022, a \$470,678 dollars administrative civil liability against Steven Jones Development Company on March 7, 2023, a settlement with Linde, Inc. on January 18, 2023, for \$30,000 towards a SEP for the California Green Works Corporation South Los Angeles Urban Greening and the Community Forestry Program, administrated by the Rose Foundation, and settlement of 35 complaints for stormwater effluent violations using our expedited settlement process for a total of \$282,000 dollars.

Chair Camacho opened the floor for questions from the Board members.

Board Members Méndez, Muñoz and Stahl made comments and asked questions. Jenny Newman and Hugh Marley responded to Board members comments and questions.

Item 6 – Update from State Water Board [Board Member Laurel Firestone]

Board Member Laurel Firestone provided updates of the following items: 1) Governor Newsom signed two executive orders to capture floodwater to recharge groundwater. The executive orders provided recommendations on the State's drought response action by the end of April 2023. On March 22, 2023, the State Water Board held a Water Use Sufficiency workshop on the proposed regulatory framework. 2) A notice of proposed rulemaking on hexavalent chromium will be distributed in the next few weeks. The State Water Board will consider adopting the proposal by the end of 2023. 3) The notice on the proposed rulemaking on direct portable use will be distributed in spring 2023. A public hearing on the notice will be held in the summer of 2023 and a consideration by the State Water Board will be held later this year. 4) Public comments for the hearing on the California Integrated Report will be accepted until April 3, 2023. A revised report with public comments will be released in the winter of 2023. Consideration of adoption of the revised report is expected in the winter of 2023 or in 2024.

Chair Camacho opened the floor for questions from the Board members.

Board Member Stahl made comments. Board Member Laurel Firestone responded to Board Member Stahl's comments.
