

## **PUBLIC NOTICE**

ACTION TO VOID AND SET ASIDE ORDER NO. R4-2006-0074
AMENDING LOS ANGELES COUNTY MS4 PERMIT, ORDER NO. 01-182
(NPDES PERMIT NO. CAS004001)

The Los Angeles County Flood Control District, the County of Los Angeles, and 84 incorporated cities contained therein (with the exception of the City of Long Beach) discharge waste from their municipal separate storm sewer system (MS4). These discharges are currently regulated under waste discharge requirements contained in Order No. 01-182 adopted by this Regional Board on December 13, 2001. Order No. 01-182 was subsequently amended by this Regional Board on September 14, 2006 by Order No. R4-2006-0074 to incorporate requirements to implement the Santa Monica Bay Beaches Summer Dry Weather Bacteria TMDL (SMB Bacteria TMDL), on August 9, 2007 by Order No. R4-2007-0042 to incorporate requirements to implement the Marina del Rey Harbor Mothers' Beach and Back Basins Bacteria TMDL, and December 10, 2009 by Order No. R4-2009-0130 to incorporate requirements to implement the Los Angeles River Watershed Trash TMDL.

As a result of a legal challenge to Order No. R4-2006-0074 by the County of Los Angeles and the Los Angeles County Flood Control District (collectively, "County"), the Los Angeles Superior Court issued a peremptory writ of mandate on July 23, 2010 requiring the Regional Board to void and set aside Order No. R4-2006-0074 amending Order No. 01-182 (Los Angeles Superior Court Case No. BS122724). On October 19, 2010, the Executive Officer, pursuant to his delegated authority, voided and set aside the operative requirements of Order No. R4-2006-0074 as they pertain to the SMB Bacteria TMDL. On October 20, 2010, the Regional Board filed a return to the writ showing what the Board did to comply with the writ. On November 18, 2010, Heal the Bay, Natural Resources Defense Council, and Santa Monica Baykeeper filed an administrative petition with the State Water Resources Control Board challenging the Executive Officer's action in removing the SMB Bacteria TMDL provisions from the permit. On December 1, 2010, the County filed with the Los Angeles Superior Court a motion to strike the Regional Board's return to the writ, arguing that additional provisions of the permit should have been voided and set aside. After a hearing held on January 6, 2011, the Court granted the County's motion to strike, finding that the Regional Board did not adequately void and set aside Order No. R4-2006-0074. The Regional Board was thereafter ordered to comply with the writ and file another return by May 31, 2011.

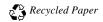
