NOTICE OF PUBLIC MEETING ON REVISED WATERSHED MANAGEMENT

PROGRAMS (WMPs) PURSUANT TO THE LOS ANGELES COUNTY MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT AND

DISCLOSURE OF EX PARTE COMMUNICATION

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to discuss the revised Watershed Management Programs (WMPs) submitted to the Board pursuant to the Los Angeles County MS4 Permit. Permittees and interested persons are invited to attend the meeting, which will be held on:

Pursuant to Part VI.C.4.e. of the Los Angeles County MS4 Permit, permittees that elected to develop a WMP that do not have an approved WMP by April 28, 2015 shall be subject to the baseline requirements of the Permit. The Los Angeles Water Board has delegated authority to its Executive Officer to approve or deny the revised WMPs on behalf of the Los Angeles Water Board. The focus of the meeting will be the Executive Officer's pending consideration of the revised WMPs for approval or denial. The meeting will provide a forum for permittees and interested persons to discuss the revised WMPs with the Executive Officer and staff.

In addition to the Executive Officer, a quorum of Los Angeles Water Board members may be in attendance during the meeting to listen to comments, ask questions, and provide feedback to the Executive Officer. However, no action or voting will take place at this meeting.

In addition, on March 25 2015, Executive Officer Samuel Unger was copied on an e-mail communication from Liz Crosson of Los Angeles Waterkeeper containing written comments on the revised WMPs from Los Angeles Waterkeeper, NRDC, and Heal the Bay. Mr. Unger did not respond to the e-mail communication. Under Government Code section 11430.10, subdivision (a), the e-mail communication constitutes an ex parte communication to the Executive Officer from an interested person in a pending proceeding, regarding an issue in the proceeding. without notice and opportunity for all parties to participate in the communication. The Los Angeles Water Board's pending approval or denial of the revised WMPs is subject to the prohibition on ex parte communications. Permittees and interested persons may not communicate with Los Angeles Water Board members or the Executive Officer regarding the pending approval or denial of the revised WMPs except through oral comments at this meeting.
