RESOLUTION NO. R1-2004-0019

FISCAL YEAR 2004-05  
STATE REVOLVING FUND LOAN PROGRAM PRIORITY LIST

WHEREAS, the State Water Resources Control Board manages the State Revolving Fund Loan Program to provide loans to communities for: 1) construction of, and improvements to municipal wastewater collection, treatment, and disposal facilities; and 2) nonpoint source, storm drainage pollution, and estuary enhancement projects to eliminate threats to public health; and

WHEREAS, the State Water Resources Control Board requires the California Regional Water Quality Control Boards to provide recommendations for State Revolving Fund Program project priorities; and

WHEREAS, the California Regional Water Quality Control Board, North Coast Region has received requests from the following communities or their representatives for inclusion on the State Revolving Fund Loan Program Priority List,

THEREFORE, BE IT RESOLVED THAT the California Regional Water Quality Control Board, North Coast Region, recommends the following additions and/or modifications to the Fiscal Year 2004-05 State Revolving Fund Priority List:

Priority Class A - Projects to alleviate existing or potential public health problems:

No projects.

Priority Class B - Projects to comply with water quality objectives for an impaired water body:

No projects.

Priority Class C - Projects to comply with waste discharge requirements and water recycling projects:

City of Dorris – add improvements to treatment system for meeting secondary treatment standards.

City of Fort Bragg – delete Project No. 49-19-11, Class C, treatment plant upgrades.

City of Fort Bragg – decrease funding for treatment plant improvements to \$1,250,000 (existing project on current priority list, Project No. 4734-11).

City of Fort Bragg – add manhole installation project.

City of Fort Bragg – add purchase of street sweeper.

City of Fort Bragg – decrease funding to \$694,000 for inflow and infiltration correction (existing project on current priority list, Project No. 4920-11).

City of Fort Bragg – decrease funding to \$425,000 for force main replacement (existing project on current priority list, Project No. 4921-11).

City of Fort Bragg – increase funding to \$1,500,000 for construction of effluent sand filters (existing project on current priority list, Project No. 4918-11) (to comply with CDO No. R1-2003-0067).

Graton Community Service District – add inflow and infiltration rehabilitation to include surface investigation of manholes and cleanouts, flow monitoring, limited video and smoke testing, repair of cleanouts and manholes, replace/repair collection lines.

Graton Community Service District - add groundwater monitoring studies related to increasing recycled water capacity.

Graton Community Service District - add installation of holding pond cover over treatment storage ponds.

Graton Community Service District – add installation and design of subsurface drip irrigation system to expand recycled water disposal capacity.

Graton Community Service District - add maintenance projects to improve treatment plant performance and capacity, including runoff diversions (improvement of dikes to prevent flooding of plant) and holding pond cleaning.

Graton Community Service District - add implementation of conservation plan to reduce flows to treatment plants including education and outreach, bulk purchase of low flow toilets, and flow restrictors.

City of Healdsburg - delete project for effluent disposal system (existing project on current priority list, Project No. 4466-11).

City of Montague – add replacing sections of the collection system to eliminate infiltration and inflow, including improvement to treatment system components.

City of Ukiah WWTP – increase funding for wastewater treatment upgrade and change in disposal method (existing project on current priority list, Project No. 4938-11).

Fortuna City WWTP – add expansion of WWTP hydraulic capacity.

Fortuna City WWTP – add odor control and solids handling.

Garberville Sanitary District – add I/II reduction.

Grenada Sanitary District – add improvements to treatment facility for meeting secondary treatment standards.

Happy Camp Sanitary District – add upgrades to lift stations, pumps, and collection system and treatment facility components.

Loleta POTW – add improved method for solids handling to reduce disposal costs.

Loleta POTW – add identification and replacement of problem areas in collection system and I/I reduction.

Loleta POTW – add development of pretreatment requirement, increase plant capacity, add aeration basin, treatment facility upgrades.

Mendocino CSD – increase funding to \$650,000 for sludge dewatering process. (existing project on current priority list, Project No. – 493611)

Mendocino County Waterworks District No. 2 – add lift station rehabilitation.

Redway POTW – add rehabilitation of collection system and I/I reduction.

Rio Dell City WWTF – add identification, evaluation, pilot testing, and implementation of alternative disposal for treated effluent (to comply with CDO No. R1-2003-46).

Rio Dell City WWTF – add facility upgrades.

Rio Dell City WWTF - add project to reduce I & I.

Russian River CSD - add equalization basin project.

Russian River CSD - delete Project No. 4644-11, Class C, treatment collection, and disposal - Summerhome Park.

Russian River CSD – delete project No. 4643-11 for upgrade facilities – Guerneville.

Russian River CSD – delete Project No. 4821-11 for treatment plant expansion and upgrades.

Sonoma County PRMD - increase funding to 3 million for septic to sewer conversion (existing project on current Priority List Project No. 4640-11).

Town of Fort Jones – add upgrades to treatment system for meeting secondary treatment standards.

Priority Class D - Projects serving as preventative measures against additional water quality degradation for impaired or unimpaired water bodies:

Sonoma County PRMD – add mitigation of individual wastewater systems in the community of Salmon Creek.

Priority Class E - Other Projects:
