On February 8, 2018, the California North Coast Regional Water Quality Control Board will consider adoption of the above-proposed modification Order. This Order proposes modifications to existing CDO No. R1-2012-0102 that includes providing a nine month extension of the compliance schedule for the Facility to complete a capital improvement project to bring the Facility into compliance with effluent limitations for biochemical oxygen demand, total suspended solids, total coliform, chlorine residual, copper, lead, silver, cyanide, dichlorobromomethane, chlorodibromomethane, bis(2-ethylhexyl) phthalate, ammonia, and nitrate. The modified Order also requires the Permittee to submit a revised Pollution Prevention Plan that includes a plan for operational improvements that will prevent pollutant from discharging to the Dutch Bill Creek Watershed.

The Regional Water Board will accept oral comments and evidence on the proposed modifications to CDO No. R1-2012-0102 at the hearing. Only the modifications identified in Order No. R1-2018-0007 are open to public comment.
