Rescission of Waste Discharge Requirements

The California Regional Water Quality Control Board, North Coast Region (Regional Water Board) finds that:

Granite Construction Company (Formerly Parnum Paving)

1. Granite Construction Company owns and operates a sand and gravel extraction, washing, and processing facility at 4201 North State Street, Ukiah, in Mendocino County. The discharge of waste from gravel washing operations was authorized by WDRs Order No. 80-100, adopted by the Regional Water Board in 1980.

2. On October 26, 2012, Regional Water Board staff received confirmation that the Facility at 4201 North State Street will no longer be in operation. The discharge of waste has ceased and the requirements contained in Order No. 80-100 are no longer needed for the protection of water quality.

Bohan and Canelis

3. Bohan and Canelis owns and operates a sand and gravel extraction, washing, and classifying operation adjacent to Austin Creek approximately one mile upstream from its confluence with the Russian River. The discharge from the washing operations was authorized by WDRs Order No. 83-138, adopted by the Regional Water Board on November 29, 1983.
4. On June 29, 2011, Regional Water Board staff received a technical report describing the Facilities updated wastewater system. The new system is fully contained and recycles all water back to the washing plant for reuse. The discharge of waste has ceased and the requirements contained in Order No. 83-138 are no longer needed for the protection of water quality.

Shamrock Materials, Inc.

5. Shamrock Materials, Inc. owns and operates a gravel processing and concrete batch plant, located at 30022 Levee Road in Cloverdale, Sonoma County. The discharge of washwater from the gravel processing operations was authorized by WDRs Order No. 87-110, adopted by the Regional Water Board on October 29, 1987.
6. On November 13, 2012, Regional Water Board staff received confirmation that operations at the Cloverdale Facility will no longer take place. The discharge of waste has ceased and the requirements contained in Order No. 87-110 are no longer needed for the protection of water quality.

Syar Industries, Inc.

7. Syar Industries, Inc. owns and operates a gravel processing facility, located in Windsor, Sonoma County. The discharge of washwater from the gravel processing operations was authorized by WDRs Order No. 87-109, adopted by the Regional Water Board on October 29, 1987.
8. On February 08, 2013, Regional Water Board staff received confirmation that operations at the Windsor Doyle Facility are no longer taking place. The discharge of waste has ceased and the requirements contained in Order No. 87-109 are no longer needed for the protection of water quality.

Syar Industries, Inc.

9. Syar Industries, Inc. owns and operates a gravel processing facility, located at 13666 Healdsburg Ave in Healdsburg, Sonoma County. The discharge of washwater from the gravel processing operations was authorized by WDRs Order No. 87-123, adopted by the Regional Water Board on October 29, 1987.
10. On February 08, 2013, Regional Water Board staff received confirmation that this facility is using a closed-loop water recycling system and no washwater from the processing activities is discharged to the evaporation/percolation ponds. Thus, the discharge of waste has ceased and the requirements contained in Order No. 87-123 are no longer needed for the protection of water quality.

THEREFORE, IT IS HEREBY ORDERED that Waste Discharge Requirements Order Nos. 80-100, 83-138, 87-110, 87-109, 87-123 and associated Monitoring and Reporting Programs be rescinded.
