## The Executive Officer's Report:

Matt St. John, Executive Officer (E.O.) presented various awards to staff. Cathy Goodwin, Water Resource Control Engineer, NPDES Unit, was awarded the Superior Accomplishment Award for her exceptional and dedicated work in conjunction with the State Board and the Division of Drinking Water, to understand and master the complex regulations of recycled water use and to work with the municipalities who are interested in using recycled water to augment the use of domestic water, particularly for irrigation. ## **Information Items**

- 7. Update on Science-Based Decision-Support Tools for Estimating Riparian Corridors. David Kuszmar, Water Resource Control Engineer, Planning Unit, introduced Karen Gaffney, Conservation Planning Manager & Tom Robinson, Conservation Planner, Sonoma County Agricultural Preservation and Open Space District; and Scott Dusterhoff, Geomorphologist, San Francisco Estuary Institute (SFEI) who gave a presentation on riparian zones, their importance and impacts in California, along with the Riparian Zone Estimation Tool (RipZET) developed by SFEI, with an overview of its purpose, applications and modules with the next steps in the continued development of existing and future RipZET modules. Karen Gaffney, gave the background of the Sonoma County Agricultural Preservation and Open Space District, along with the focus and function of the organization in protecting riparian corridors with easements and fee titles. Tom Robinson, gave an overview of the foundational environmental data collection tool available to a consortium of Sonoma County agencies to access detailed vegetation and topographical maps through the use of LiDAR (Light Detection and Ranging) mapping to assist in riparian zone conservation easements, water resource and flood management, and detailed the next steps of the use of this information by the Sonoma County Agricultural Preservation and Open Space District.
- 8. **Update on Industrial Storm Water Program and New Permit Implementation**. Mona Dougherty, Senior Water Resources Control Engineer, NPDES Unit, gave an overview and the history of the Storm Water Program. Devon Jorgenson, Scientific Aide, NPDES Unit, gave a presentation on the 2013-2014 Annual Report review and follow-up actions. Paul Keiran, Water Resource Control Engineer, NPDES Unit, gave a presentation on the reissued Industrial Storm Water General

Permit and the significant changes made, highlighting the implementation successes of three facilities, and the future work priorities of the Industrial Storm Water Program.

- 9. **Issues to Consider for Future Board Strategic Planning Discussion**. Matt St. John, Executive Officer, initiated a conversation with the Board members regarding what topics/categories each Board member would like to discuss at a future Board strategic planning meeting.
- 10. **Executive Officer's Report**. Matt St. John, Executive Officer, informed the Board that the Regional Water Board staff are in the early stages of developing a Regional Monitoring Program for the Russian River and that he and Shin-Roei Lee, Division Chief, Planning, Stewardship & Compliance Unit, will be meeting tomorrow with representatives of the Russian River Watershed Association, City of Santa Rosa, Sonoma County Water Agency, and San Francisco Estuary Institute to advance the discussion about the purpose and objectives of the Regional Monitoring Program in the Russian River Watershed.
- 11. **Board Member Requests for Future Agenda Items.** Board member Noren requested that he and a Cleanup Unit staff work with Duane DeWitt, Roseland resident, to address his concerns of the Roseland area, through either a Board item or a tour of the area. Board member Noren also requested information regarding the new Federal EPA 404 Program and how that affects the Regional Board's authority with the 401 Program.
