State Board Liaison's and Executive Officer's Reports: State Board Liaison Dorene D'Adamo updated the Board on the State Water Board's actions regarding 1) Reporting of water shut-offs during Covid-19 Pandemic, 2) On April 27 & 30, 2020, State Board staff attended <a href="The Water Research Foundation">The Water Research Foundation</a> 's virtual International Water Research Summit on environmental surveillance of sewer-shed monitoring for pathogens (SARS, Covid-19) that is a promising tool to assess community spread, 3) On May 5, 2020, the State Board adopted the Environmental Lab Accreditation Program (ELAP) regulation standards for over 650 laboratories with a 3-year phase-in, 4) On May 5, 2020, the State Water Board adopted the 10-year Safe Drinking Water Policy and will have a Board Workshop on July 22, 2020, to develop the Safe Drinking Water Expenditure Plan, 5) At the June 16, 2020 State Board meeting, the State Water Board adopted the Definition of Microplastics in Drinking Water that was ordered by the State of California Legislature, 6) In May, 2020, State Board staff conducted workshops to receive public input on the proposed Vapor Intrusion Workgroup Supplemental Guidance, that outlines a

uniform framework for state and local agencies that oversee cleanups to determine if harmful vapors formed by contaminants in soil or groundwater pose a threat to the buildings occupants, and 7) The State Board is working on revisions to the Winery General Order and are working closely with the Regional Boards, and plan to hold a workshop sometime in mid-July 2020 on this topic.

## **Action Item**

6. Consideration of Resolution No. R1-2020-0013 authorizing referral of Water Code violations by Shadow Light Ranch, LLC, Joshua Sweet, and The Hills, LLC to the Office of the Attorney General for judicial civil enforcement. Josh Curtis, Assistant Executive Officer, introduced Shannon Utley, Engineering Geologist, Northern Cannabis Regulatory Unit, North Coast Regional Water Board, and Dan Kippen, Attorney, State Water Board Office of Enforcement. Mr. Kippen updated the Board on the Resolution, that refers Shadow Light Ranch, LLC, Joshua Sweet, and The Hills, LLC (collectively, the Responsible Parties) to the California Office of the Attorney General (Attorney General) for possible enforcement of violations of the Water Code related to the Responsible Parties' extensive illegal development of property for cannabis cultivation. The Resolution requests that the Attorney General seek injunctive relief, bring other applicable causes of action, and/or seek judicially imposed civil liabilities or other appropriate relief under California Water Code sections 13350 and/or 13385, as appropriate, against the Responsible Parties. Due to the significant issues explained in detail in the staff report, including the Responsible Parties' failure to comply with the requirements regarding discharge of waste to waters of the state and/or United States, Regional Water Board staff contends that this case is warranted for referral to the Attorney

General. Following the staff presentation, the Responsible Parties' attorney, Nicole Granquist, commented on the status of existing site conditions and her client's attempts to achieve compliance with the alleged violations. The Board deliberated regarding the testimony and the implications of referring the case to the Office of the Attorney General.

## Information Items

- 7. Update on the Development and Early Implementation of the Laguna de Santa Rosa Total Maximum Daily Loads for Nutrients, Dissolved Oxygen, Sediment, and Temperature. Dr. Kelsey Cody, Environmental Scientist, Adaptive Management Unit, updated the Board on the development and early implementation of the Laguna de Santa Rosa Total Maximum Daily Loads for Nutrients, Dissolved Oxygen, Sediment, and Temperature. Key Next Steps: (1) Staff will continue coordinating with US EPA and State Board TMDL staff to develop agreement on the contents of a TMDL Alternative that both satisfies regulatory requirements and establishes a science-based, meaningful approach to source control and ecosystem recovery; (2) Staff will continue to assemble the existing science associated with sediment, nutrient, temperature, and DO conditions in the Laguna de Santa Rosa watershed into a technical report to submit for scientific peer review; (3) Staff will coordinate with key watershed partners to develop the first in what may be a series of Laguna Recovery Workshops through which a consensus-based recovery strategy can be built.
- **8. Storm Water Program Update.** Heaven Moore, Senior Water Resource Control Engineer, NPDES Unit, updated the Board on the Storm Water Program, including the Statewide Industrial General Permit, Construction General Permit, and Municipal Separate Storm Sewer System Permits.
- **9. Covid-19 Update and Budget Implications.** Matt St. John updated the Board on the Region's response to the changed work environment due to Covid-19 and the associated budgetary and resource implications for the region.

- 10. Executive Officer's Report. Matt St. John provided additional information regarding the State Water Board's development of the Winery General Order; welcomed Chris Watt as the new Groundwater Specialist in the Point Source Control & Groundwater Protection Division; and highlighted that this year is shaping up to be another dry year with low flows in the North Coast streams that present risks to salmonids and other aquatic life.
- 11. Board Member Requests for Future Agenda Items and Other Items of Interest: Chairwoman Quinto requested an update on the Potter Valley Project, with Vice-Chairman Giusti concurring.
