NOTICE OF OPPORTUNITY TO COMMENT, PUBLIC WORKSHOP, AND PUBLIC HEARING ON REVISIONS TO A BASIN PLAN AMENDMENT REGARDING THE RUSSIAN RIVER WATERSHED PATHOGEN TOTAL MAXIMUM DAILY LOAD (TMDL)

NOTICE IS HEREBY GIVEN that the North Coast Regional Water Quality Control Board (North Coast Water Board) opens a **45-day** public comment period regarding proposed updates to the Russian River Watershed Pathogen TMDL Action Plan. All updates are shown in strikethrough and underline. The North Coast Water Board will conduct a public workshop at the regularly scheduled Board meeting in August 2021 and will consider adopting an amendment to the Water Quality Control Plan for the North Coast Region (Basin Plan) reflecting those updates at the December 2021 Board Meeting.
