Rescission of Waste Discharge Requirements

The California Regional Water Quality Control Board, North Coast Region (Regional Water Board) finds that:

1. On December 1, 1988, the Regional Water Board adopted Waste Discharge Requirements (WDR), Order No. 88-145, requiring American Aircraft Painting to comply with discharge prohibitions and effluent limitations for activities associated with the stripping and removal of paint.
2. The discharger has requested to have the American Aircraft Painting WDR, Order No. 88-145, rescinded because the facility is no longer in operation. The discharge of waste has ceased and the requirements contained in Order No. 88-145 are no longer needed for the protection of water quality.
3. On May 25, 1988, the Regional Water Board adopted WDR, Order No. 88-70, requiring Thomas N. Jordan Jr. dba Jordan Vineyard and Winery to comply with discharge prohibitions and effluent limitations for the treatment and discharge of domestic waste at their facility in Healdsburg, California. Order No. 88-70 permitted the discharge of a combined waste stream that included both domestic waste and winery waste into reclaimed water irrigation. Order No. 88-70 also required compliance with Contingency Planning and Notification Requirements Order No. 74-151 and Monitoring and Reporting Program No. 88-70.
4. In 2008, Thomas N. Jordan dba Jordan Vineyard changed design specifications to include separation of process and domestic wastes. Jordan Vineyards and Winery has enrolled under the General Waste Discharge Requirements for Discharges of Winery Waste to Land Order No. R1-2002-0012 as well as the General Waste

Discharge Requirements for Discharges to Land by Small Domestic Wastewater Treatment Systems Order No. 97-10-DWQ. Waste discharges at the Jordan Vineyard and Winery are regulated under Order No. R1-2002-0012 and Order No. 97-10-DWQ, therefore the requirements contained in the WDR, Order No. 88-70 are no longer needed for the protection of water quality.

5. On August 23, 2001 the Regional Water Board adopted WDR Order No. R1-2001-0104 requiring the Old Woolen Mill facility to comply with discharge prohibitions and effluent limitations for the treatment and discharge of waste in Eureka, California. At the time of permitting, the Old Woolen Mill site was undergoing remediation which involved, in part, the reuse of treated soil.
6. On December 10, 2007 the Old Woolen Mill (Former) site was recommended for case closure. On June 20, 2008 Regional Water Board staff received the final items requested in the case closure letter. On October 21, 2008 Regional Board Staff requested rescission of WDRs because all onsite operations had ceased, and therefore Order No. R1-2001-0104 is no longer needed for the protection of water quality.
7. On May 26, 1983 the Regional Water Board adopted WDR Order No.83-059 requiring the Kaiser Sand and Gravel facility to comply with discharge prohibitions and effluent limitations for the treatment and discharge of waste in Healdsburg, California. The discharger operated a sand and gravel crushing, screening, and washing operation adjacent to the Russian River. All waste water from the operation was discharged to evaporation/ percolation ponds and recycled back to the processing plant.
8. On December 15, 2008 Carroll L. LaGraffe, requested rescission of Order No. 83-059. Operations ceased in 2002, the facility has been removed and no further operations will occur onsite. Order No. 83-059 is no longer needed for the protection of water quality.
9. This action to rescind WDRs is not subject to the California Environmental Quality Act (CEQA) (Public Resources Code Section 21000 et seq.), pursuant to Title 14, California Code of Regulations, Sections 15060(c)(2) and 15061(b). Based on the foregoing findings and the facts underlying them, this action to rescind WDRs cannot reasonably be expected to have any potentially significant adverse effect on the environment.
10. On September 10, 2009 after due notice to the Permittees and all other affected persons, the Regional Water Board conducted a public hearing and evidence was received regarding rescission of the WDRs.

THEREFORE, IT IS HEREBY ORDERED that Waste Discharge Requirements, Order Nos. 88-145, 88-70, R1-2001-0104, 83-059, and associated Monitoring and Reporting Programs are rescinded except for enforcement purposes.
