


Cannabis Identification and Prioritization System (CIPS)



Background

- July 2014, pilot program initiated
- FY 2017-18, budget allocated additional positions & statewide program established
- FY 2020-2021, budget shortfalls require substantial reduction in program staff

Ongoing Program Challenges

- Low Cultivator Participation
 - Local jurisdictions ban or severely limit cultivation
 - Uncertainty in regulatory landscape further discourages growers from enrolling in Water Boards' program.
- Impacts fee revenue and cannabis tax revenue, both of which fund the Water Boards' Cannabis Program.
- Significant additional cannabis licensing fees and taxes impacting Water Boards ability to raise fees

Program Funding

- Limited tax allocation and fees shortfall
 - Resulted in a significant reduction (50%) in the Program's Water Quality staff statewide.
 - Division of Water Rights also required to hold positions vacant for extended time & small reduction in staff

Program Changes

Reduce Program Scope - Enforcement

- Illegal Cultivation is Priority
- More Restricted Targeted Priority Watershed Approach
- Limit Enforcement Outside Targeted Priority Watersheds
 - Limited to sites with one or more elevating factors

Program Changes

Reduce Program Scope - Regulatory Activity

- Deprioritize Enforcement for Permitted Grows
- Deprioritize Compliance Assessment and Inspection of Enrolled Sites
- Limit Enrollment Application Review
- Centralize processing of Notices of Applicability at State Water Board

Next Steps

- Identify and Track Program Metrics
- Develop Program Goals for 2020/2021FY
 - Focused on enrollments & illegal cultivation enforcement
- Develop Work Plan to Obtain Program Goals

 - Resolve Open Enforcement Cases
 - New Cases Only if Egregious

Operational Changes

- Transition to specialist-based work assignments
- Utilize central point of contact for customer service
- Assign technical work to managers
- Leverage the resources of agency partners
- Increase reliance on ministerial processes, self-certification, self-reporting, remote sensing
- Conduct reviews / assess conditions at larger spatial scales

Highlights + Takeaways

- Cannabis cultivators in CA remain very active.
- The Statewide and North Coast Cannabis Programs are facing some challenges.
- Staffing levels are down by 50%.
- Tough choices are required.
- Statewide priorities are clear.
- Our work to protect water quality work continues!
