8. **Executive Officer's Report.** Matt St. John, highlighted the implementation steps taken regarding the Cannabis Waste Discharge Order: (1) work with the State Water Board to develop an electronic enrollment submittal process, (2) develop a mailer to inform Region 1's public of the Cannabis Order, (3) hold enrollment clinics to assist

the public in the enrollment process, (4) continue to work with California Department of Fish & Wildlife regarding each agencies roles and responsibilities when participating in joint inspections, (5) finalize a guidance document for prospective 3rd party programs to clarify the process by which they need to submit a proposal to be formally approved as a 3rd party program, (6) use aerial imagery to identify properties that are potentially growing and send out letters of notice to those property owners to enroll in the program, (7) develop an in-house manual for Water Board staff to follow, i.e. the do's and don'ts of what to say when engaged with the cannabis cultivators.

9. **Board Member Requests for Future Agenda Items.** Board member Noren requested an agenda informational item discussion on the Russian River water quality issues as it pertains to blue-green algae, flow augmentation and TMDL requirements, including participation by Sonoma County Water Agency.
