


Policy Need

- Degradation of streams and wetlands linked to 86 percent of temperature impairments and 75 percent of sediment impairments in the Region
- Basin Plan does not provide comprehensive framework for addressing cumulative impacts of stream and wetland degradation
- Inconsistent permit requirements across programs and between projects
- FLD, WQE, and WET beneficial uses adopted in 2003, but no implementation plan to protect them



- Biodiversity maintenance







Scientific Concept: Systems




Scientific Concept: Riparian Areas
