The report provides a summary of the application status, actions taken this calendar year, actions proposed for the calendar year 2019, and the proposed date for final action for each pending application. Although this report does not include a listing of priority for pending applications in the subject counties, priority is reflected in the "proposed final action date" column of the report. In general, low to moderate priority projects are assigned later final action dates than high priority projects and will note "no action to be taken until staff resources available" in the proposed actions column of the report. The summary shall include a description of the status of each pending application, the actions taken in the preceding year, proposed actions for the upcoming year, and the proposed date for final action with regard to that application; and (b) For the purposes of carrying out subdivision (a), the board may post the information described in subdivision (a) on its web site.
