

Below is a note I've written to the local paper re the Mill Valley sewage spills. Bottom line: a fine punishes ME. I didn't do anything!

If Sewerage Agency of Southern Marin agrees to terminate the employees responsible for this, and come up with some mechanism for punishing the supervisors who clearly didn't train/supervise the employees, can you reconsider the fine? (Actually, even if you do fine me and my neighbors, \$1.6 million for something we couldn't control, can you please see that some heads at SASM roll. Otherwise the Bay will continue to have spills.)

One key detail is missing in your story: who will actually pay the fine. I'm sure that the Sewerage Agency of Southern Marin (SASM) will state that they have insurance, but most of us understand how insurance works - there's a deductible, and after the incident, the rates are adjusted to recapture the payment made. Bottom line: we, the residents, will pay for this.

OK - There's no way around that. But I would like to know how many people at SASM have lost their jobs over this ineptitude. If you work at a convenience store you'll get fired if your register drawer is off by \$50. I'm sure it's the same in a bank. What happens at Sewerage Agency of Southern Marin when there's ineptitude at this scale, polluting the Bay, and costing customers so much? How many of those responsible have been told to find another line of work?
