Subject: Administrative Civil Liability Complaint No. R2-2009-0030 for Uni Tile & Marble Inc., Hayward, Alameda County

Dear Mr. Pan:

Enclosed is Complaint No. R2-2009-0030 (Complaint) issued as an administrative civil liability in the amount of \$26,290 against Uni Tile & Marble, Inc. (Company). The Complaint alleges that the Company discharged industrial storm water to Waters of the State and Waters of the United States without a permit in violation of California Water Code Section 13376.

The Prosecution proposes that the Regional Water Board consider the Complaint during a meeting that will commence at the time and place indicated below:

Date/Time: **October 14, 2009, 9:00 a.m.**
Place: Auditorium, Elihu Harris State Building
1515 Clay Street, Oakland

Enclosed you will find the Hearing Procedure that the Regional Water Board typically follows in conducting the public hearing. Any objections to this hearing process shall be sent to the Regional Water Board's Advisory Team by **July 27, 2009, at 5:00 p.m.**, or they will be waived. The Advisory Team contact information is included in the Hearing Procedure.

The Company has the following options:

1. The Company can appear before the Regional Water Board at the meeting to contest the matter. Written comments and evidence shall be submitted by the deadline indicated

below and in accordance with the process set forth in the attached Hearing Procedure. At the meeting, the Regional Water Board may impose an administrative civil liability in the amount proposed or for a different amount, decline to seek civil liability, or refer the case to the Attorney General for judicial enforcement.

2. The Company can waive its right to the 90-day hearing requirement in order to engage in settlement discussions.
3. The Company can waive its right to a hearing to contest the allegations contained in the Complaint by completing the waiver attached to the Complaint.

If the company waives its hearing rights, it must submit a copy of the signed waiver by the time and date specified below to the attention of Sandia Potter of the Regional Water Board Advisory Team with a copy to David Elias of the Prosecution Team.

The deadline for submittal of a waiver and for submittal of written comments and evidence on the Complaint is **August 17, 2009, at 5 p.m.** The deadline for submittal of a Supplemental Environmental Project proposal(s) is **August 26, 2009, at 5 p.m.**
