I believe you all have already received this, but in case you did not attached is a pdf letter of the Regional Water Board staff's comments regarding the City's Storm Water Development Standards. Additionally, City staff and Regional Board staff will meet during the week of April 14 to discuss the Regional Board staff's further specific comments on the SWDS.

Following that meeting, City staff will revise the SWDS to address comments received both in that letter and during that meeting. Once we've revised the SWDS to address the Water Board staff's comments, we will distribute the revised SWDS to the Stakeholders Committee for review and comment and will schedule a meeting with the Stakeholder Committee. As indicated in the Water Board staff's letter, the City is to complete its revisions within 45-days of the date of the letter (May 17, 2008). City staff intend to meet that date.

We will be in contact with you in the next couple of days to set a meeting date and time. We are tentatively looking at April 30 or May 5 from 1:00-3:00.
