
Central Coast Regional Water Quality Control Board (Water Board) staff has prepared the draft revised Waste Discharge Requirements Order No. R3-2007-0045, draft Monitoring and Reporting Program No. R3-2007-0045, and draft Staff Report for the Santa Maria Class III Landfill. The Water Board will hear public comments and consider this matter at its October 19, 2007 Board meeting in Santa Barbara.

Interested parties not able to access the documents electronically may request to receive a hard copy delivered by mail. Interested parties must submit comments on the subject document no later than **September 4, 2007**. The Water Board will not accept comments or other written submissions on the draft Order after September 4, 2007, unless the Water Board Chairman rules that exclusion would create a severe hardship, and that the late submission will not prejudice any party or the Water Board. Any person submitting late comments must explain why the materials were not submitted by September 4, 2007. The Water Board Chairman will rule on late submittals at or before the hearing. Late submissions that consist of evidence (as opposed to policy statements or comments) are generally prejudicial unless all designated parties and Water Board staff have time to consider the evidence before the meeting.
