PROPOSED ISSUANCE OF WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT

The United States Navy (hereinafter the Navy or Permittee) discharges secondary or tertiary-treated wastewater from its San Clemente Island Wastewater Treatment Plant (SCI WWTP) to the Pacific Ocean, a water of the United States, at Discharge Point 002 located 250 feet east of the SCI WWTP on the northeast end of the island approximately 1,000 feet south of Wilson Cove. The Navy owns and operates the SCI WWTP, a federally-owned treatment works located at the Navy Auxiliary Landing Field, San Clemente Island, CA. The SCI WWTP has a secondary treatment design capacity of 0.06 million gallons per day (MGD) and a tertiary treatment design capacity of 0.03 MGD. The discharge is regulated under waste discharge reguirements contained in Order No. R4-2018-0156, adopted by the Los Angeles Water Quality Control Board (Los Angeles Water Board) on November 8, 2018. Order No. R4-2018-0156 serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0110175). The Permittee filed a Report of Waste Discharge (ROWD) and applied to the Los Angeles Water Board for reissuance of Waste Discharge Requirements (WDRs) and NPDES permit on July 27 and August 14, 2023 to discharge secondary and tertiary-treated wastewater to the Pacific Ocean. The application was deemed complete on December 13, 2023. The terms and conditions of the current NPDES permit have been automatically continued and remain in effect until new WDRs and NPDES permit are adopted pursuant to the proposed Order.

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board tentatively propose to issue consolidated WDRs and the NPDES permit under title 40 of the Code of Federal Regulations (40 CFR) § 124.4(c)(2).

Interested persons are invited to attend. At the public hearing, the Los Angeles Water Board will hear any testimony pertinent to the discharge, tentative WDRs, and NPDES permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

The entire file (ROWD, other documents relied upon, tentative effluent limitations and special provisions, comments received, and other information) will become a part of the administrative record of this proceeding, irrespective of whether individual documents are specifically referenced during the hearing. The entire file will not be present in the hearing room. Should any interested persons desire staff to bring to the hearing any documents that are not included in the agenda packet, they must submit a written or electronic request to staff during business hours, not later than five business days before the hearing. The request must identify the documents with enough specificity for staff to locate them.

NATURE OF HEARING

This will be a formal adjudicative hearing pursuant to section 648 et seq. of title 23 of the California Code of Regulations. Chapter 5 of the California Administrative Procedure Act (commencing with section 11500 of the Government Code) will not apply to this proceeding.

Ex Parte Communications Prohibited: As a quasi-adjudicative proceeding, no board member may discuss the subject of this hearing with any person, except during the public hearing itself. Any communications to the Los Angeles Water Board must be directed to staff.

PUBLIC COMMENTS AND SUBMITTAL OF EVIDENCE

Persons wishing to comment on, or object to, the tentative WDRs and NPDES permit, or submit evidence for the Los Angeles Water Board to consider, are invited to submit them in writing to Xiaofei Cui at xiaofei.cui@waterboards.ca.gov. To be evaluated and responded to by the Los Angeles Water Board, included in the Los Angeles Water Board's agenda folder, and fully considered by the Los Angeles Water Board, written comments or testimony regarding the tentative must be submitted by **5:00 p.m. on March 18, 2024**. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

HEARING PROCEDURE

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, the Los Angeles Water Board staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Los Angeles Water Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to three minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than **April 11, 2024**, (two weeks prior to the hearing) to discuss how much time they believe is necessary for their presentations, and the Los Angeles Water Board staff will endeavor to accommodate reasonable requests. At the conclusion of

testimony, the Los Angeles Board will deliberate in open or close session, and render a decision.

The Board meeting does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting on **May 23, 2024**. A continuance will not extend any time set forth herein.
