TENTATIVE RESCISSION OF CEASE AND DESIST ORDER NO. 01-009 AND AMENDED CEASE AND DESIST ORDER NO. R4-2003-0061 FOR MALIBU BAY CLUB, 41000 PACIFIC COAST HIGHWAY, VENTURA COUNTY, CALIFORNIA (FILE NO. 72-006, CI-5774)


On January 11, 2001, the Los Angeles Regional Water Quality Control Board (Regional Board) adopted Waste Discharge Requirements (WDR), Order No. 01-008 and Cease and Desist Order (CDO) No. 01-009 for the Malibu Bay Club Condominiums for the discharge of primarily and secondarily treated domestic wastewater from the residences of the condominiums. On April 3, 2003, the Board amended the CDO and adopted Amended Cease and Desist Order No. R4-2003-0061 to extend the time for compliance with WDR Order No. 01-008. The Malibu Bay Club Condominiums are located at 41000 Pacific Coast Highway in the Malibu area of unincorporated Ventura County.

The Ventura Regional Sanitation District (Discharger) has achieved compliance with the final effluent limits in WDR Order No. 01-008 as the CDO and Amended CDO directed. Therefore, staff will propose rescission of CDO No. 01-009 and Amended CDO No. R4-2003-0061.

In accordance with administrative procedures, this Regional Board, at a public hearing, will consider the enclosed tentative Order, which, in part, will rescind CDO No. 01-009 and Amended CDO No. R4-2003-0061. The hearing will be held on February 5, 2009, at the Monrovia Council Chambers, 415 S. Ivy Avenue, Monrovia, California, and will begin at 9:00 a.m.

The California Regional Water Quality Control Board, Los Angeles Region, finds:

1. This Regional Board adopted cease and desist order and amended cease and desist order for the Discharger listed below.
2. The Dischargers have complied with cease and desist order (CDO) and amended CDO to upgrade the treatment systems for full compliance of waste discharge requirements adopted by the Regional Board for respective discharges.
3. Therefore, the following cease and desist order and amended cease and desist order are no longer necessary and should be rescinded.
4. The following Order is hereby rescinded, except for enforcement purposes.
5. The rescission of time schedule order is exempt from the provisions of Chapter 3 (commencing with Section 21100), Division 13, Public Resources Code, in accordance with Water Code Section 13389.

The Regional Board has notified the Discharger and interested agencies and persons of its intent to consider rescission of the following cease and desist order and amended cease and desist order and has provided them with an opportunity to submit their written views and recommendations.
