NOTICE OF INTENT TO RENEW RESOLUTION R5-2005-0052 CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR DISCHARGES RELATED TO TIMBER HARVEST ACTIVITIES (WAIVER)

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is the notice of Public Hearing concerning the Notice of Intent to Renew Resolution R5-2005-0052 *Conditional Waiver of Waste Discharge Requirements for Discharges Related to Timber Harvest Activities* (Waiver). Please note that the tentative documents will receive internal legal and management review during the public comment period.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the tentative Order at its 17/18/19 March 2010 Board Meeting. The Notice of Public Hearing is enclosed.
