The tabs are described below:

Tab1: High Vulnerability - No Survey: Members who have at least one High Vulnerability Surface or Groundwater parcel that have no survey on file.

Tab2: Low Vulnerability - No Survey: Members with only low vulnerability parcels who do not have a survey on file.

Tab3: High Vulnerability - 1 Survey: Members who have at least one High Vulnerability Surface or Groundwater parcel that have the 2013 survey turned in but no survey for 2014.

Tab4: Tenant Not Complying For Member: Members who we know have a lessee/tenant who would be responsible for filling out the survey on their behalf.
