ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; CALIFORNIA DEPARTMENT OF WATER RESOURCES, LOAFER CREEK POINT STAGE 2 BOAT RAMP AND PARKING LOT PROJECT (WDID NO. 5A04CR00295A1), BUTTE COUNTY

This Order responds to the 9 June 2020 request for an amendment of the Loafer Creek Point Stage 2 Boat Ramp and Parking Lot Project Section 401 Water Quality Certification (WDID No. 5A04CR00295). The original Water Quality Certification (Certification) was issued on 11 September 2019. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

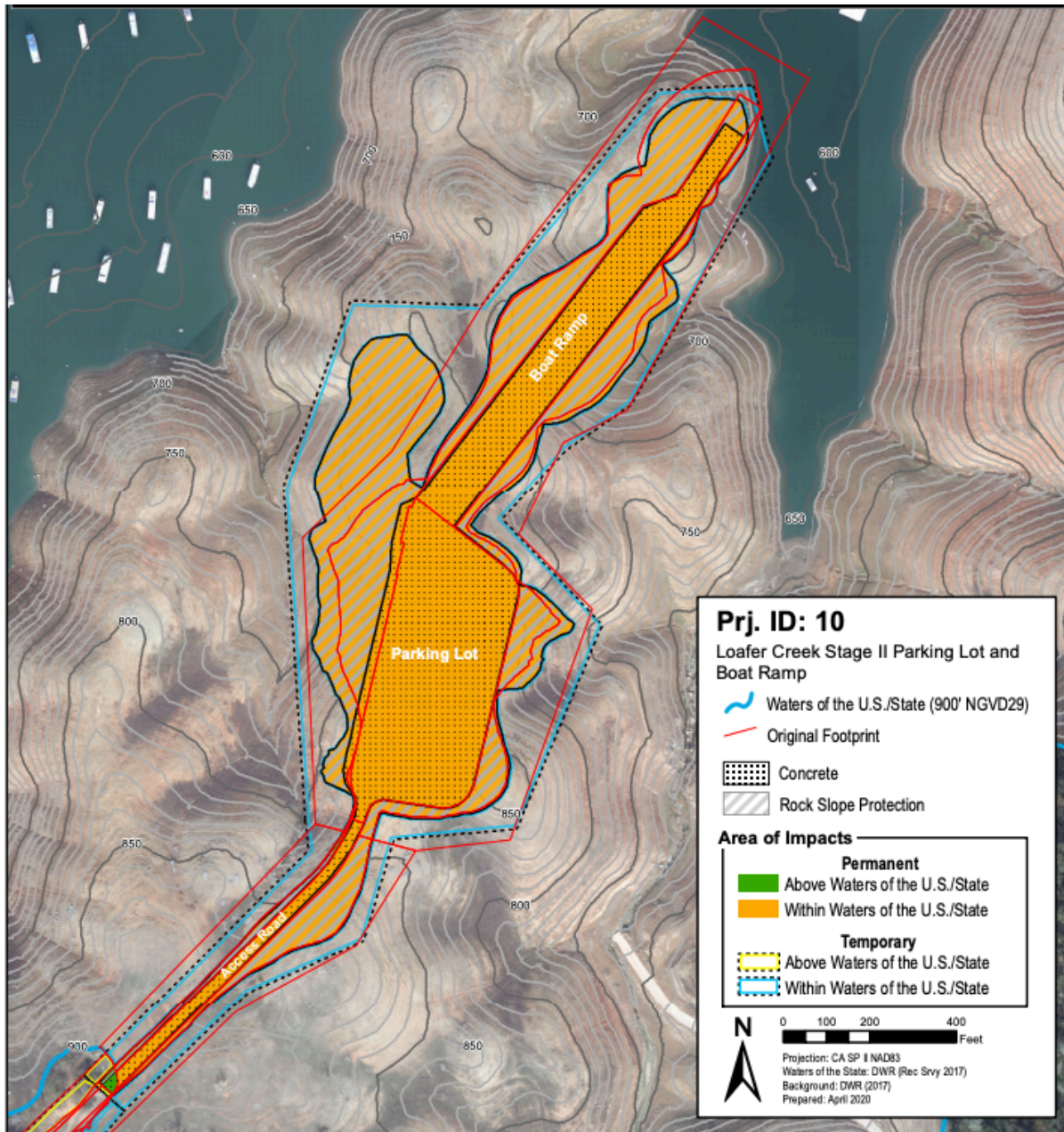
