ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; JESPER PETERSEN REVOCABLE TRUST, CROFTWOOD UNIT 2 PROJECT (WDID#5A31CR00519A1), PLACER COUNTY

This Order responds to the 18 January 2022 request for an amendment of the Croftwood Unit 2 Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00519). The original Water Quality Certification (Certification) was issued on 28 February 2020. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Jesper Petersen Revocable Trust is requesting a change in ownership and a time extension through 14 March 2026 to coincide with expiration of the United States Army Corps of Engineers 2021 Nationwide Permits. The name change will allow TL Partners XVII, L.P. to proceed with the Project described in the original Certification. A time extension was authorized by the United States Army Corps of Engineers on 4 May 2022, and the California Department of Fish and Wildlife on 21 April 2022.

TL Partners XVII, L.P. has provided documentation from the United States Army Corps of Engineers (SPK-2017-00015) and the California Department of Fish and Wildlife authorizing in-water construction activities to continue until 14 March 2026.

The Certification is hereby amended as described below:

1. TL Partners XVII, L.P. is the legal permittee for the original Certification.
2. The Project implementation timeframe has been extended until 14 March 2026 to coincide with the expiration of the 2021 Nationwide Permits as authorized by the United States Army Corps of Engineers.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$1,638.00 for the original Certification were received on 25 June 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
