### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; TEKIN & ASSOCIATES, LLC, LONETREE APARTMENTS PROJECT (WDID#5A31CR00555A1), PLACER COUNTY**

This Order responds to the 16 August 2022 request for an amendment of the Lonetree Apartments (Project) Section 401 Water Quality Certification (WDID#5A31CR00555). The original Water Quality Certification (Certification) was issued on 30 June 2022. The requested amendment is hereby approved.

The original Certification is therefore amended as described below.

#### **AMENDMENT:**

Tekin & Associates, LLC is requesting a modification to correct a clerical error section K 3a.pg.20 of the Clean Water Act Section 401 Water Quality Certification and Order, from 10.2 acres to 1.02 acres. The correction will make the amount consistent with the application materials and Attachment B of the Certification.

The Certification is amended as shown below:

#### **3. Total Required Compensatory Mitigation**

- a. The Permittee is required to provide compensatory mitigation for the authorized impact to streambed and vernal pool impacts by purchasing 1.02 acres of in-lieu fee credits through the Western Placer County In-Lieu Fee Program.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$18,782.00 for the original Certification were received on 28 February 2022. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
