**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; SIERRA COUNTY
DEPARTMENT OF PUBLIC WORKS, SAILOR RAVINE DAMAGE REPAIRS
PROJECT (WDID#5A46CR00029A1), SIERRA COUNTY**

This Order responds to the 27 September 2021 request for an amendment of the Sailor Ravine Damage Repairs Project (Project) Section 401 Water Quality Certification (WDID#5A46CR00029). The original Water Quality Certification (Certification) was issued on 4 January 2021. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Sierra County Department of Public Works is requesting a time extension for work completion from 1 October 2021 to 25 February 2026. The Project has not commenced as of the 27 September 2021. Sierra County Department of Public Works has requested an extension from the United States Army Corps of Engineers for SPK-2020-00622 under the updated 2022 Nationwide Permit coverage.

The Certification is amended to extend the authorization of in-water work to reflect as approved through 25 February 2026.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$1,949.00 for the original Certification were received on 22 June 2020. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
