REVISED NOTICE OF APPLICABILITY 2004-0012-DWQ-0033; GENERAL WASTE DISCHARGE REQUIREMENTS FOR THE DISCHARGE OF BIOSOLIDS TO LAND FOR USE AS A SOIL AMENDMENT IN AGRICULTURAL, SILVICULTURAL, HORTICULTURAL, AND LAND RECLAMATION ACTIVITIES; SYNAGRO WEST, LLC, CITY OF TURLOCK, AND TURLOCK REGIONAL AVIATION ASSOCIATION; SYNAGRO-TURLOCK AIRPORT RANCH BIOSOLIDS (ME-40) LAND APPLICATION AREA; MERCED COUNTY

On 10 October 2022, Synagro West, LLC (Synagro), the City of Turlock, and the Turlock Regional Aviation Association (TRAA) were issued Notice of Applicability (NOA) 2004-0012-DWQ-0033 for coverage under the State Water Resources Control Board's, *General Waste Discharge Requirements for the Discharge of Biosolids to Land for Use as a Soil Amendment in Agricultural, Silvicultural, Horticultural, and Land Reclamation Activities* (General Order).

On 2 August 2023, Synagro and TRAA submitted a Notice of Intent (NOI) to amend NOA 2004-0012-DWQ-0033 and expand the biosolids application area to include two adjacent fields. Biosolids application rates will remain the same with up to three dry tons/acre/year applied depending on crop requirements. Soils in the area are predominantly Rocklin loam and San Joaquin sandy loam consisting of moderate to well drained soils. Baseline soil analysis shows similar range in metals and nutrient concentrations. Based on the information provided, the expanded application area meets the required conditions for approval under the General Order. Therefore, NOA 2004-0012-DWQ-0033 is hereby revised to include the fields listed in Table 1.

**Attachments A and B** have also been revised to show the location of the new fields and site boundaries with applicable buffer zones around wells, drainage features, and residences. All other Specific Conditions as stipulated in the original NOA including setbacks, application requirements, loading rates, and conditions shall remain the same.

#### MONITORING AND REPORTING PROGRAM

The General Order includes Monitoring and Reporting Program (MRP) 2004-0012-DWQ. MRP 2004-0012-DWQ requires the submittal of an annual monitoring report by **15**<sup>th</sup> **February** of each year identifying quantity of biosolids applied to the various fields and cumulative pollutant loading calculations.

All monitoring reports and other correspondence should be converted to a searchable Portable Document Format (PDF) and submitted electronically. Any person aggrieved by this action of the Central Valley Water Board may petition the State Water Resources Control Board to review the action in accordance with California Water Code section 13320 and California Code of Regulations, title 23, sections 2050 and following. The State Water Resources Control Board must receive the petition by 5:00 p.m., 30 days after the date of this NOA, except that if the thirtieth day following the date of this NOA falls on a Saturday, Sunday, or state holiday, the petition must be received by the State Water Resources Control Board by 5:00 p.m. on the next business day. <u>Copies of the law and regulations applicable to filing petitions</u> may be found on the internet (http://www.waterboards.ca.gov/public\_notices/petitions/water\_quality) or will be provided upon request.

Coverage under the General Order shall become effective subject to this Revised Notice of Applicability immediately.




