**NOTICE OF TERMINATION FOR GENERAL ORDER NO. R5-2008-0149,  
FORMER SHELL SERVICE STATION, 5730 FOLSOM BOULEVARD, SACRAMENTO,  
SACRAMENTO COUNTY**

On 15 March 2010, the Executive Officer of the Central Valley Regional Water Quality Control Board issued a Notice of Applicability under Order No. R5-2008-0149, *In-Situ Groundwater Remediation at Sites with Volatile Organic Compounds, Nitrogen Compounds, Perchlorate, Pesticides, Semi-Volatile Compounds, Hexavalent Chromium and/or Petroleum Hydrocarbons*. In the Notice of Applicability the project was assigned site-specific Order No. R5-2008-0149-06. Remediation conducted under this project began with injection on 15 and 16 July 2010. Post injection monitoring was conducted through the third quarter 2011.

In a 6 December 2011 email, Mr. Tom Magney of Conestoga-Rovers & Associates requested termination of coverage for the Project. Therefore, through this letter, General Order No. R5-2008-0149-06 is hereby terminated as of the date of this letter. Invoicing for General Order coverage will be modified accordingly.
