The City of Nevada City, is the owner and operator of the Nevada City Wastewater Treatment Facility, hereinafter Discharger, a wastewater collection, treatment, and disposal system providing sewerage service to domestic users of the City of Nevada City. The treatment system consists of grit removal, comminution, biological treatment in sequencing batch reactors, sand filtration, pH adjustment, and chlorination/dechlorination. Secondary effluent is further treated through a traveling bridge sand filter.

The effluent is discharged to Deer Creek, a water of the United States, a tributary to the Yuba River within the Sacramento River watershed.

A public hearing concerning this matter will be held during the Regional Water Board meeting which is scheduled for:

The designated parties for this hearing are as follows:

- City of Nevada City staff

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **5:00 PM on 24 October 2008**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The tentative Waste Discharge Requirements were issued on **24 September 2008**. Persons wishing to comment on this noticed hearing item shall submit testimony,

evidence, if any, and/or comments in writing to the Regional Water Board no later than **5:00 PM on 24 October 2008**. Written evidence or comments submitted after **5:00 PM on 24 October 2008** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
