**TENTATIVE WASTE DISCHARGE REQUIREMENTS GENERAL ORDER  
FOR  
DAIRIES WITH MANURE ANAEROBIC DIGESTER  
OR CO-DIGESTER FACILITIES**

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) has released a tentative Waste Discharge Requirements General Order for Dairies with Manure Anaerobic Digester or Co-Digester Facilities (Order). The proposed Order will serve as general Waste Discharge Requirements (WDRs) for discharges of dairy and dairy manure digester or co-digester waste from dairy facilities with manure anaerobic digesters or co-digesters. This Order will apply to the owners of land upon which a dairy digester or a dairy co-digester is located, the owners of the dairy and the dairy digester or co-digester facility and/or the operators of the dairy and the dairy digester or co-digester facilities.

A public hearing concerning this matter will be held during the Central Valley Water Board meeting, which is scheduled for:

The tentative Order was issued on 29 September 2010. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than by noon on **1 November 2010**. Written materials submitted after noon on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Central Valley Water Board Chair.

All interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony will be limited in time by the Central Valley Water Board Chair. Interested persons may be asked to respond to clarifying questions from Central Valley Water Board members, counsel staff or others, at the discretion of the Central Valley Water Board.
