NEVADA COUNTY**

The City of Nevada City (Discharger) owns and operates a Wastewater Treatment Plant (Facility), which provides wastewater treatment service for the City of Nevada City serving a population of 3,100. The Facility provides tertiary treatment for up to 0.69 million gallons per day (MGD) of wastewater. Existing Order R5-2008-0177 (existing NPDES Permit) allows the tertiary treated wastewater to be discharged to Deer Creek, a tributary to the Yuba River.

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider renewal of the Discharger's existing NPDES Permit. The Tentative Permit renewal includes new and/or more stringent effluent limitations for ammonia and lead. The renewal also proposes granting dilution for dichlorobromomethane, a chlorine byproduct.

The designated parties for this hearing are as follows:

- City of Nevada City

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **20 April 2012**. The request must explain the basis for status as a designated party and, in particular, how the person is directly affected by the discharge.

Persons wishing to comment on the noticed hearing item must submit testimony, evidence, and/or comments in writing to the Central Valley Water Board no later than 5:00 p.m. on **20 April 2012**. Written evidence or comments submitted after 5:00 p.m. on **20 April 2012** will not be accepted and will not be incorporated into the administrative record if doing so would

prejudice any party. All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
