NOTICE OF PUBLIC HEARING

The Calaveras County Water District is the owner and operator of the Copper Cove Wastewater Reclamation Facility (Facility), a publicly owned treatment works located at 5130 Kiva Place, Copper Cove, CA. During the summer, typically June through August, tertiary treated wastewater is discharged to Pond NC-2D located on the Saddle Creek Golf Course. The Title 22 disinfected tertiary recycled water in Pond NC-2D is used for golf course irrigation or to provide makeup water for the jurisdictional wetland system, waters of the United States, and tributary to Littlejohns Creek.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2006-0081, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 3 August 2006. An Order is proposed to renew the NPDES permit.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 8 April 2013**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m.** on

8 April 2013. Written evidence or comments submitted after **5:00 p.m.** on **8 April 2013** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
