NOTICE OF PUBLIC HEARING

TENTATIVE WASTE DISCHARGE REQUIREMENTS

for

PILOT TRAVEL CENTERS, LLC
PILOT TRAVEL CENTER NO. 168
YOLO COUNTY

Tentative Waste Discharge Requirements (WDRs) are being issued to Pilot Travel Centers, LLC as the owner and operator, also known as the Discharger for the Pilot Travel Center No. 168 (Facility) located at 30035 County Road 8 in Yolo County. The Facility consists of five treatment and disposal ponds which serves a travel center, stand-alone diner-style restaurant, and a truck care service building. The Facility is currently regulated by WDRs Order 05-01-266. The tentative WDRs were updated to ensure the discharge is consistent with water quality plans and policies and to reflect current treatment and disposal operations.

This public meeting may take place either in-person or via video and teleconference, and/or any combination of the two, but the format may be changed in the future. Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide

comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 26 April 2022**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

The Tentative WDRs were issued for a 30-day public comment period on **25 March 2022**. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than by **5:00 p.m. on 26 April 2022**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Central Valley Water Board Chair. A party requesting to submit late materials must demonstrate good cause for the late submission, and the Central Valley Water Board Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Central Valley Water Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Central Valley Water Board members, counsel staff or others, at the discretion of the Central Valley Water Board.
