A Public Hearing has been scheduled for the Central Valley Regional Water Quality Control Board (Central Valley Water Board) to consider adoption of the proposed Order at its **13/14 October 2022** Board Meeting. See the enclosed Notice for additional information about the Public Hearing. The Discharger must post one (1) copy of the Notice at the nearest city hall or county courthouse, one (1) copy at the post office nearest to the Park (if allowed), and one (1) copy at the public entrance to the Park. Please post the Notice as soon as possible and provide proof of posting, using the enclosed form, by **18 August 2022**.
