In response, Nick Panchev, elected as spokesperson by the People of Hinkley, being 49 litigants within 35 lawsuits, with current operative SECOND AMENDED COMPLAINT (SAC), hereby respond to the the Lahontan Regional Water Quality Control Board, hereinafter the ("Board"), as follows:

1. Cautionary Notes:

(A) Project Navigator, LTD, hereinafter ("Entity1"), is nor representing all in the community and/or all residents and property's owners in the town of Hinkley, CA 92347, including but not limited to that was found to be biased as to these forty nine people from Hinkley, CA 92347, and therefore all comments by said entity are hereby subjected to STRIKING ON ADMINISTRATIVE LEVEL, including but not limited to subjected to the pending filing of TEMPORARY RESTRAINING ORDER (TRO), to be striked during the upcoming Jury trial, by those 49 litigants within the 35 cases;

(B) The so called "COMMUNITY ADVISORY COMMITTEE (CAC) hereinafter ("Entity 2"), is nor representing all in the community and/or all residents and peopery's owners in the town of Hinkley, CA 92347, including but not limited to that was found to be biased as to those forty nine people from Hinkley, CA 92347, and therefore all comments by said entity are hereby subjected to STRIKING ON ADMINISTRATIVE LEVEL, including but not limited to subjected in pending filing of TEMPORARY RESTRAINING ORDER (TRO), to striking withing the upcoming Jury trial, those 49 litigants within the 35 cases;

(C) Recent personal communications with Mr. Izbicki from USGS, has triggered suspicion of bias, including but not limited to being paid for certain study by Pacific Gas and Electric Company, that could trigger not only STRIKING ON ADMINISTRATIVE LEVEL, by striking of any or all data submitted to the Board and/or to any governmental and private entities, via striking withing the upcoming
