ORDER NO. 83-66

RESCISSION OF WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

1. The below listed Board Resolution and Orders contain waste discharge requirements for waste discharge facilities that are no longer in use, or were never constructed, or have been connected to a municipal sewer system, or had Orders updated without the correct rescission, or have a discharge that is now considered insignificant.
2. It is desirable to rescind said below-listed Board Orders and Resolution.
3. The Board forwarded timely notices by mail to persons responsible for each of the below-listed Orders and the Resolution, explaining the Board's considerations of rescinding the particular Resolution or Order, and requesting timely comments.
4. The Board at a public hearing heard and considered all comments pertaining to the proposed rescinding of the below-listed Orders and Resolution.
