ORDER NO. 85-1

**WASTE DISCHARGE REQUIREMENTS
FOR
CAMPER RESORTS OF AMERICA
Cathedral City - Riverside County**

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

1. DAT Development Company (hereinafter also referred to as the discharger), 1888 Century Park E. #708, Los Angeles, California, 90067, verified via the park manager updated information on the discharge of waste on September 17, 1984.
2. The discharger is discharging a maximum of 17,000 gallons-per-day of domestic sewage from a recreational vehicle park having 150 recreational vehicles spaces, a laundry room, a recreation building and four (4) restrooms. The wastewater is discharged into septic tank/seepage pit disposal systems located in the SE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 28, T4S, R5E, SBB&M. About 50 of the spaces are without hookups.
3. The discharger is reserving areas of sufficient size for possible future 100 percent replacement of the seepage pits.
4. The discharge has been subject to waste discharge requirements contained in Board Order No. 78-24.
5. There are no domestic wells within 200 feet of the discharge facilities described in Findings No. 2 and 3 (above).
6. The discharger informs that wastewater from a swimming pool, wading pool and hot pool is periodically discharged into separate seepage pits.
7. Desert Water Agency has installed an eighteen (18) inch sewer main that extends along the southern boundary of the park, and connects to the Coachella Valley Water District sewerage system.
8. The Water Quality Control Plan for the Colorado River Basin Region of California was adopted by the Regional Board on November 14, 1984. The Basin Plan contains water quality objectives for Coachella Hydrologic Subunit.
9. The beneficial uses of ground water of the Coachella Hydrologic Subunit are:

- a. Municipal supply
- b. Industrial supply
- c. Agricultural supply

10. The Board has notified the discharger and interested agencies and persons of its intent to update waste discharge requirements for the discharge.
11. The Board in a public meeting heard and considered all comments pertaining to the discharge.
12. These waste discharge requirements govern an existing facility, which the discharger is currently operating, and therefore is exempt from the provisions of the California Environmental Quality Act in accordance with Section 15301 of Title 14, Chapter 3 of the California Administrative Code.

IT IS HEREBY ORDERED, the discharger shall comply with the following:

A. Discharge Specifications


1. Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code.
2. No wastewater other than domestic sewage and swimming and hot pool wastewater shall be discharged at this location.
3. Wastewater discharged subsurface shall be retained underground with no surfacing.
4. Adequate measures shall be taken to assure that flood or surface drainage waters do not erode or otherwise render portions of the discharge facilities inoperable.
5. Septic tank cleanings shall be discharged only by a duly authorized service.
6. Swimming pool and hot pool wastewater shall not be discharged into a sewage disposal system.

B. Provisions

1. Sufficient land area shall be reserved for possible future 100 percent replacement of the seepage pits, until such time as this park is connected to a municipal sewerage system.
2. Upon request from this Board's Executive Officer, the discharger shall furnish technical and/or monitoring reports on the treatment and discharge of waste.
3. Prior to any modifications of this facility which would result in material change in the quality or quantity of wastewater discharged, or any material change in location of discharge, the discharger shall report in writing to the Regional Board.

4. Prior to any change of ownership of this recreational vehicle park, the discharger shall:
 - a. Specify as a condition of transfer that the area specified in Provision B.1 (above) remain servient to the park for the purpose of providing additional subsurface sewage disposal capacity, until such time as this park is connected to a municipal sewerage system.
 - b. Transmit a copy of this Order to the succeeding owner or operator, and file a copy of the transmittal letter with this Board.
5. This Order supersedes Board Order No. 78-24.

1. Annual reports are to be submitted by January 15th of each year to:




