#### **Atwell Phase II Residential Development Project**

#### I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of Pardee Homes (Permittee) for the Atwell Phase II Residential Development Project (Project). This Order is for the purpose described in the application submitted by the Permittee. The application was received on October 22, 2019. The application was deemed complete on May 1, 2020.

#### **II. Public Notice**

The Colorado River Basin Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from November 8, 2019 to November 29, 2019. The Colorado River Basin Water Board did not receive any comments during the comment period.

## **III. Project Purpose**

The purpose of the Project is to construct a master-planned community and associated infrastructure over approximately 305.70 acres of land in the City of Banning.

### **IV. Project Description**

The Butterfield Specific Plan (Specific Plan) proposes residential housing, parks, open space, school sites, and commercial uses over 1,523.4 acres of developable land. A maximum of 4,862 dwelling units could be developed pursuant to the Specific Plan. The Specific Plan is proposed for development in eight (8) phases over an estimated 30-year implementation period in response to various factors including the cyclical nature of the housing market and other variations in demand. Associated infrastructure would be constructed incrementally to match the needs of development as it occurs.

The Project, which is Phase II of the Butterfield Specific Plan, will include the construction of 362 low and medium density residential units, parks, open space land use components, and associated on and off-site infrastructure over approximately 305.70 acres of land. The Project will include the construction of interior roadways and street right-of-way (ROW) improvements along Meadowline Way/"H" Street and Highland Springs Avenue. The Project includes the installation of wet and dry utilities, in particular, the relocation and upgrading of the existing 30-foot Southern California Gas pipeline, as well as the construction of basins that will serve as both water quality best management practices (BMPs) and as peak flow attenuation (retention) basins. Temporary project staging and stockpile areas would occur within the uplands.

#### Single Family Residential Land Uses

Single family residential development would account for approximately 75.21 acres of land and would provide for up to 144 medium density residential (MDR) units and 218 low density residential (LDR) units within several planning areas. MDR development would allow for 5.52 dwelling units (DU)/acre and LDR development would allow for approximately 4.38 DU/acre.

#### Roadways and Road Right-of Way Improvements

The Project will include the construction of new interior roadways which will include the construction of "G" Street and the partial construction of Oak Valley Parkway/"H" Street from Smith Creek to Highland Home Road to the east.

The Project will also include ROW improvements along Highland Springs Avenue. Highland Springs Avenue would be improved with half-improvements to accommodate an ultimate 104-foot to 128-foot ROW, including a raised median; four travel lanes (i.e. two on each side of the median), and a 6-foot emergency or bike lane on each side of the street.

#### Open Space and Parks

The Project will include approximately 18.0 acres of Open Space and 2.20 acres of parks/recreation. Approximately 10% of park land use components will consist of impervious surfaces.

### Drainage and Storm Water Management Improvements

Phase II is presented as a stand-alone project which includes features to satisfy all applicable regulations related to stormwater management and flood control. As subsequent phases of Atwell are presented for approval, additional detail related to stormwater management will be presented. All of the stormwater features of Phase II are designed to be compatible with later phases of the larger Atwell project.

Proposed improvements associated with the Project will include onsite features such as basins and a manmade creek as well as offsite features. A proposed berm and swale will line the northern boundary of the Project to collect any offsite flow and debris that may originate in the undeveloped portions of the Atwell Property north of Phase II. The swale will redirect the flow safely into the manmade "West Branch Creek", while the berm redirects towards the existing Smith Creek. Offsite flows originating from the west will be collected in a proposed temporary basin and discharged into the existing Smith Creek channel.

Smith Creek lies east of the Project and in peak flood conditions is predicted to overflow onto lands adjacent to Phase II. Phase II will be graded to create lots at least 1 ft. above Smith Creek's predicted 100-year flood surface elevation, preventing Smith Creek from inundating any portion of Phase II. Along the site boundary, a proposed revetment of rolled erosion control product (RECP) will be installed to protect against the encroaching floodplain water surface levels.

#### V. Project Location

The Butterfield Specific Plan area is located north of Wilson Street, east of Highland Springs Road, west of Highland Home Road, north and northwest of the present terminus of Highland Home Road, and south of the unincorporated portion of Riverside County, generally north of the extended alignment of Brookside Avenue into the San Bernardino Mountain foothills. The site is generally surrounded by unincorporated Riverside County and portions of the San Bernardino Mountains to the north and northeast, Highland Home Road and the Banning Bench to the east, the City of Beaumont and existing residential development to the east and south, Wilson Street to the south, and Highland Springs Avenue and the City of Beaumont to the west. Land allotted for the Butterfield Specific Plan site is currently used for livestock grazing and has been extensively disturbed by periodic disking, grazing, and contour farming.

The Project site (Phase II) is located in the City of Banning, Riverside County, California. Township/Range: T3S R1W Section 1, T2S R1W Section 36, and T2S R1E Section 31 (Latitude 33.945700°, Longitude -116.942881°). Maps showing the Project location are found in Attachment A of this Order.

#### VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Colorado River Basin Water Board. Receiving waters and groundwater potentially impacted by the Project are protected in accordance with the Water Quality Control Plan for the Colorado River Basin Region (Basin Plan) and other plans and policies, which may be accessed online at: http://www.waterboards.ca.gov/plans policies/. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the U.S./state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

Project impact and receiving waters information can be found in Attachment B.

Table 1 of Attachment B shows the receiving waters and beneficial uses of waters of the U.S. impacted by the Project. Individual impact location and quantity is shown in Table 2 of Attachment B.

## VII. Description of Direct Impacts to Waters of the State/U.S.

The Project site has six drainage features, which include all or portions of Drainages A, C, C-1, D, F, and Smith Creek. The drainages within the Project site are jurisdictional waters that are direct tributaries to Smith Creek. Several agricultural/ranching berms and their associated borrow areas are present as part of the ongoing ranching operation which is currently functioning on site. The drainage features within the Project site have been significantly degraded by cattle as part of the ranching operation and are considered unvegetated and/or do not support wetland/riparian vegetation.

The Project will result in unavoidable permanent impacts to Smith Creek, Drainage A, Drainage D, and Drainage F associated with road construction and

utility line placement within set roadway/utility line easement areas. The type of fill material proposed to be discharged includes typical road construction materials such as structure, soil, sand, cement, wire, pipe, etc. Permanent impacts to Drainages C and C-1 would occur as a result of single-family residential development and its associated infrastructure.

Project staging areas and stockpile areas would occur in adjacent upland areas outside of existing jurisdictional waters, and no fuel modification zones are associated with the Project.

Total Project fill/excavation quantities for all impacts are summarized in Table 1. Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading ecological conditions only.

## VIII. Compensatory Mitigation

As mitigation for temporary and permanent impacts to 0.41 acre of jurisdictional dry wash, the Permittee has agreed to provide mitigation at a 2:1 mitigation to impact ratio.

### IX. California Environmental Quality Act (CEQA)

On June 6, 2011, the City of Banning, as lead agency, prepared a notice of availability for a draft Environmental Impact Report for the Project. On March 27, 2012, the City of Banning certified the Final Environmental Impact Report (FEIR) (State Clearing House (SCH) No. 2007091149) and adopted a Mitigation Monitoring and Reporting Program (MMRP). The City of Banning filed a Notice of Determination (NOD) with the SCH on March 30, 2012 and several subsequent NODs thereafter. In December 2016, the City of Banning prepared an Addendum to the FEIR. The City Council approved the Addendum on February 14, 2017.

As a responsible agency, the Colorado River Basin Water Board has reviewed and considered the environmental documents prepared by the City of Banning and finds that they address the Project's water resource impacts. (Cal. Code

Regs., tit. 14, § 15096, subd. (h).) Pursuant to CEQA, the Colorado River Basin Water Board has made Findings of Facts (Findings) supporting the issuance of this Order in Attachment C.

#### X. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Resources Control Board (State Water Board) to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

#### XI. Fees Received

An application fee of \$1,638 was received on October 22, 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3) and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator. An additional fee of \$5,485 based on total Project impacts was received on August 24, 2020.

#### XII. Conditions

The Colorado River Basin Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

#### A. Authorization

Impacts to waters of the state shall not exceed quantities shown in Table 1.

#### B. Reporting and Notification Requirements

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment E, including specifications for photo and map documentation during the Project.

Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment E, which must be signed by the Permittee or an authorized representative.

#### 1. Project Reporting

a. **Monthly Reporting:** The Permittee must submit a Monthly Report to the Colorado River Basin Water Board on the 15<sup>th</sup> day of each month for the duration of the construction phase. Monthly reporting shall continue until the Colorado River Basin Water Board issues a Notice of Project Complete Letter to the Permittee.

b. Annual Reporting: The Permittee must submit an Annual Report including activities conducted for the previous fiscal year (July 1 -June 30) to the Colorado River Basin Water Board on the 1<sup>st</sup> of September. Annual Reports must be submitted even if Project construction has not begun. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee by the Colorado River Basin Water Board.

c. Other Reporting: If pollutants are observed in surface water, the Permittee shall submit a report to the Colorado River Basin Water Board within 30-days after encountering the pollutants and describe actions taken to correct the problem and provide photographic documentation that supports the information in the report.

If repairs are required, the Permittee shall take pictures of the area where work needs to take place, documenting the before and after conditions of the area; and shall maintain a daily log for each site where work is taking place pursuant to this Order, while the Permittee conducts its repair activities. The log shall:

- · Provide a general description of the repair work;
- · Specify the date and daily starting and ending time for the repair work;
- Note key weather conditions (e.g., temperature, wind speed and direction, precipitation, if any);
- Include notes from visual observations regarding the presence/absence of construction debris/trash (e.g., discarded filter fiber) and used oil (e.g., oil that leaks from construction equipment) in the area where the work has taken place.

Within 30 days following completion of all repair work, the Permittee shall submit to the Colorado River Basin Water Board a summary report of the key daily log entries. The summary report shall include the abovementioned before and after pictures of the conditions of the area and shall be signed by the Permittee's Project Manager.

#### 2. Project Status Notifications

a. Commencement of Construction:

The Permittee shall submit a Commencement of Construction Report at least seven (7) days prior to start of initial ground disturbance activities.

b. Request for Notice of Completion of Discharges Letter:

The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request

shall be submitted to the Colorado River Basin Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Colorado River Basin Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.

#### c. Request for Notice of Project Complete Letter:

The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any post-construction monitoring is complete,<sup>2</sup> and no further Project activities will occur. This request shall be submitted to Colorado River Basin Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Colorado River Basin Water Board staff shall issue a Notice of Project Complete Letter to the Permittee which will end the post discharge monitoring period and associated annual fees.

## 3. Conditional Notifications and Reports:

The following notifications and reports are required as appropriate.

## a. Accidental Discharges of Hazardous Materials<sup>3</sup>

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- i. As soon as (A) the Permittee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
  - first call 911 (to notify local response agency)
  - then call Office of Emergency Services (OES) State Warning Center at:
     (800) 852-7550 or (916) 845-8911

<sup>&</sup>lt;sup>2</sup> Completion of post-construction monitoring shall be determined by Colorado River Basin Water Board staff and shall be contingent on successful attainment of restoration and mitigation performance criteria.

<sup>&</sup>lt;sup>3</sup> "Hazardous material" means any material that, because of its quantity, concentration, or physical or chemical characteristics, poses a significant present or potential hazard to human health and safety or to the environment if released into the workplace or the environment. "Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

**ii.** Following notification to OES, the Permittee shall notify the Colorado River Basin Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.

- **iii.** Within five (5) working days of notification to the Colorado River Basin Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards: The Permittee shall notify the Colorado River Basin Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
  - i. Examples of noncompliance events include lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state/U.S., and runoff from water contact with uncured concrete.
  - **ii.** This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

#### c. In-Water Work

- i. The Permittee shall notify the Colorado River Basin Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- ii. Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Colorado River Basin Water Board staff.

#### d. Modifications to Project:

Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Colorado River Basin Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Colorado River Basin Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

#### e. Transfer of Property Ownership:

This Order is not transferable in its entirety or in part to any person or organization except after notice to the Colorado River Basin Water Board in accordance with the following terms:

- i. The Permittee must notify the Colorado River Basin Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Colorado River Basin Water Board at least 10 days prior to the transfer of ownership.
- **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.

## f. Transfer of Long-Term BMP Maintenance:

If maintenance responsibility for post-construction best management practices (BMPs) is legally transferred, the Permittee must submit to the Colorado River Basin Water Board a copy of such documentation and must provide the transferee with a copy of a long-term BMP maintenance plan that complies with manufacturer or designer specifications. The Permittee must provide such notification to the Colorado River Basin Water Board with a Transfer of Long-Term BMP Maintenance Report at least 10 days prior to the transfer of BMP maintenance responsibility.

#### C. Water Quality Monitoring

#### 1. General:

If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).

#### 2. Accidental Discharges/Noncompliance:

Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Colorado River Basin Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.

#### 3. In-Water Work or Diversions:

For projects involving planned work in water or stream diversions, a water quality monitoring plan shall be submitted to Colorado River Basin Water Board staff for acceptance at least 30 days in advance of any discharge to the affected water body. Water quality monitoring shall be conducted in accordance with the approved plan.

Sampling shall be conducted in accordance with Table 2 sampling parameters.4

#### 4. Post-Construction:

The Permittee shall visually inspect the Project site during the rainy season for five (5) years to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, the Permittee shall contact the Colorado River Basin Water Board staff member overseeing the Project within three (3) working days. The Colorado River Basin Water Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

#### D. Standard

1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, Article 6 commencing with section 3867. Additionally, the Colorado River Basin Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Colorado River Basin Water Board determines that: the Project fails to comply with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act

Grab samples shall be taken between the surface and mid-depth and not be collected at the same time each day to get a complete representation of variations in the receiving water. section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to ensure compliance with water quality standards and appropriate requirements of state law.

- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to ensure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

## E. General Compliance

- 1. Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plan by the Colorado River Basin Water Board or any applicable State Water Board water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Colorado River Basin Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provide that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.

4. The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.

- **5.** This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to ensure compliance with the water quality standards and other pertinent requirements of state law.
- **6.** The Permittee shall adhere to all requirements in the mitigation monitoring and Report Program (MMRP) within attachment C. Incorporated herein by reference and any additional measures are also outlined in Attachment C, CEQA Findings of Fact.
- 7. Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, *National Pollutant Discharge Elimination System (NPDES) General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities* (Order No. 2009-0009-DWQ; NPDES No. CAS000002).

#### F. Administrative

- **1.** Signatory requirements for all document submittals required by this Order are presented in Attachment D of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- **3.** The Permittee shall grant Colorado River Basin Water Board staff or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
  - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.

- **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
- **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
- **d.** Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.
- **5.** A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- **6.** Lake and Streambed Alteration Agreement The Permittee shall submit a signed copy of the Department of Fish and Wildlife's lake and streambed alteration agreement to the State Water Board immediately upon execution and prior to any discharge to waters of the state/U.S.

#### **G.** Construction

#### Good Site Management "Housekeeping"

- 1. The Permittee shall follow good site management "housekeeping" and implement erosion control, sediment control, and other construction-related best management practices (BMPs) depicted in Table 3 below.
- 2. A qualified biological monitor shall be on site during all ground-disturbing activities (work area preparation, grading, clearing, grubbing, trenching, construction, and decommissioning activities) to prevent impacts to special status species and other biological resources, as well as document and report any construction-related incidences.
- **3.** The area of vegetation and soil disturbance shall be restricted to the smallest extent possible.
- **4.** After completing construction activities, any disturbed areas shall be restored to pre-existing contours and conditions to the extent feasible.

#### **Hazardous Materials**

- **5.** No toxic and/or hazardous materials shall be stored near or within wash/drainage areas. To the extent practicable, these materials shall be stored offsite and placed in appropriate secondary containment.
- **6.** Spoil sites shall not be located where spoil could be washed back into the stream channel or where spoil covers aquatic or riparian vegetation. Any materials placed in seasonally dry portions of the drainage areas that could be washed downstream or could be harmful to aquatic life shall be removed from the streambed prior to inundation by high flows.
- **7.** No fueling or maintenance of equipment or vehicles shall occur adjacent or within the wash/drainage areas.

#### Roads

**8.** Work and staging areas and temporary access routes shall be sized, located, and flagged to limit potential impacts to natural areas. Previously-disturbed areas shall be used to the extent feasible.

#### Sediment Control

- **9.** The Permittee shall implement sediment control BMPs to remove sediment loads from runoff generated within the construction site for all disturbed areas. Examples: silt fence, fiber rolls, gravel bags, dewatering filtration.
- **10.** The Permittee shall implement off-site sediment tracking control BMPs for reducing the transport of sediment on tires off of and within construction site. Examples: stabilized construction entrance/exit tire wash, entrance/exit inspection and cleaning facility.

#### Stabilization/Erosion Control

11. The Permittee shall implement erosion control BMPs to mitigate soil erosion, minimize soil loss from wind erosion, and to reduce air pollution during construction activities for all disturbed areas. Examples: mulch, straw, wood chips, soil application, lot perimeter protection per county standards, bonded fiber matrix or stabilized fiber matrix, physical stabilization erosion control blanket.

#### **Stormwater**

- **12.** Work shall not be conducted during rain events.
- **13.** The Permittee shall develop and implement a Stormwater Pollution Prevention Plan (SWPPP) that complies with the requirements of the State Water Board's Construction General Permit.
- **14.** Post-construction, the Permittee shall implement channel protection BMPs to protect banks of the channels as well as the slopes.
- **15.** Post-construction, the Permittee shall implement outlet protection BMPs to reduce discharge/water velocity. Examples: energy dissipater outlet protection, velocity dissipation devices.

### H. Compensatory Mitigation for Temporary and Permanent Impacts<sup>5</sup>

## 1. Total Required Compensatory Mitigation

- a. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.41 acres of unvegetated, ephemeral stream channel by purchasing 0.82 acres (a 2:1 mitigation to impact ratio) of stream channel establishment or rehabilitation credits at a Colorado River Basin Water Board-approved mitigation bank or inlieu fee program.
- b. Total required, Project-compensatory mitigation information for temporary and permanent physical loss of area is summarized in Table 4:

### 2. Compensatory Mitigation Plan

- a. The Permittee agreed to provide compensatory mitigation for impacts to waters of the U.S/state via participation in a mitigation bank or an in-lieufee enabling instrument, for a total of 0.82 acres of re-establishment mitigation credits. The Permittee has chosen to purchase credits in the Riverpark Mitigation Bank.
- **b.** The Permittee has submitted an approved draft compensatory mitigation plan as part of a complete application. The Permittee shall provide a final compensatory mitigation plan for written acceptance by Colorado River Basin Water Board staff. The final compensatory mitigation plan shall include all plan elements as outlined in 40 C.F.R. section 230.94(c)(5)-(6).

#### 3. Purchase of Mitigation Credits by Permittee for Compensatory Mitigation

- **a.** A copy of the fully executed agreement for the purchase of mitigation credits shall be provided to the Colorado River Basin Water Board within 90 days of authorized impacts.
- **b.** The Permittee shall retain responsibility for providing the compensatory mitigation and long-term management until Colorado River Basin Water Board staff has received documentation of the credit purchase and the transfer agreement between the Permittee and the seller of credits.

#### 4. Restoration of Temporary Impact Areas

The Permittee shall restore all areas of temporary impacts to waters of the U.S./state and all Project site upland areas of temporary disturbance which could result in a discharge to waters of the U.S./state.

Pursuant to State Water Board Order No. 2003-0017-DWQ, this Order also serves as Waste Discharge Requirements (WDRs) under the Porter-Cologne Water Quality Control Act (Water Code, § 13000 et seq.).

Except insofar as may be modified by any preceding conditions, all Order actions are contingent on: (a) the discharge being limited and all proposed mitigation being completed in strict compliance with the conditions of this Order and the attachments to this Order; and, (b) compliance with all applicable requirements of statewide water quality control plans and policies and the Colorado River Basin Water Boards' Water Quality Control Plan and policies.

Attachment C CEQA Findings

#### 1. Environmental Review

On June 6, 2011, the City of Banning, as lead agency, prepared a notice of availability for a Draft Environmental Impact Report (EIR) for the Project. On March 27, 2012, the City of Banning certified the Final Environmental Impact Report (FEIR) (State Clearing House (SCH) No. 2007091149) and adopted a Mitigation Monitoring and Reporting Program (MMRP). The City of Banning filed a Notice of Determination (NOD) with the SCH on March 30, 2012 and several subsequent NODs thereafter.

Following initial Project approval by the City of Banning in 2012, litigation over the Project ensued. As part of a global settlement of the lawsuit in 2014, the Permittee agreed to a scaled down, less intense development with fewer residential units and the removal of several roadway extensions. In December 2016, the City of Banning prepared an Addendum to the FEIR. The City Council approved the Addendum on February 14, 2017.

The Colorado River Basin Water Board is a responsible agency under CEQA (Pub. Resources Code, § 21069) and in making its determinations and findings, must presume that City of Banning's certified environmental documents comport with the requirements of CEQA and are valid (Public Resources Code, §§ 21080.1(a), 21167.2). The Colorado River Basin Water Board has reviewed and considered the environmental documents and finds that the environmental documents prepared by the City of Banning address the Project's water resource impacts. (Cal. Code Regs., tit. 14, § 15096, subd. (f).) The environmental documents include the mitigation monitoring and reporting program (MMRP) developed by the City of Banning for all mitigation measures that have been adopted for the Project to reduce potential significant impacts. (Pub. Resources Code, § 21081.6, subd. (a)(1); Cal. Code Regs., tit. 14, § 15091, subd. (d).)

### 2. Incorporation by Reference

Pursuant to CEQA, these Findings of Facts (Findings) support the issuance of this Order based on the Draft EIR, FEIR, the Addendum, the application for this Order, and other supplemental documentation.

The Addendum to the FEIR is incorporated herein by reference and available at:

Requirements under the purview of the Colorado River Basin Water Board in the MMRP are incorporated herein by reference.

The Permittee's application for this Order, including all supplemental information provided, is incorporated herein by reference.

#### 3. Findings and Determination

Having considered the whole of the record, the Colorado River Basin Water Board has determined that there is no substantial evidence that the Project or any of its aspects could result in significant adverse impacts to water resources, when implemented in accordance with the mitigation measures required in MMRP and the conditions in this Order. (Cal. Code Regs., tit. 14, § 15096, subd. (h).).

The Colorado River Basin Water Board will file a NOD with the SCH within five (5) working days from the issuance of this Order. (Cal. Code Regs., tit. 14, §§ 15096, subd. (i).

- 2. A duly authorized representative of a person designated in items 1.a through 1.c above may sign documents if:
  - a. The authorization is made in writing by a person described in items 1.a through 1.c above.
  - b. The authorization specifies either an individual or position having responsibility for the overall operation of the regulated activity.
  - c. The written authorization is submitted to the State Water Board Staff Contact prior to submitting any documents listed in item 1 above.
- 3. Any person signing a document under this section shall make the following certification:

"I certify under penalty of law that I have personally examined and am familiar with the information submitted in this document and all attachments and that, based on my inquiry of those individuals immediately responsible for obtaining the information, I believe that the information is true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment."

## **Definition of Reporting Terms**

- 1. Active Discharge Period: The active discharge period begins with the effective date of this Order and ends on the date that the Permittee receives a Notice of Completion of Discharges Letter or, if no post-construction monitoring is required, a Notice of Project Complete Letter. The Active Discharge Period includes all elements of the Project including site construction and restoration, and any Permittee responsible compensatory mitigation construction.
- 2. Request for Notice of Completion of Discharges Letter: This request by the Permittee to the Colorado River Basin Water Board staff pertains to projects that have post construction monitoring requirements, e.g. if site restoration was required to be monitored for 5 years following construction. Colorado River Basin Water Board staff will review the request and send a Completion of Discharges Letter to the Permittee upon approval. This letter will initiate the post-discharge monitoring period and a change in fees from the annual active discharge fee to the annual post-discharge monitoring fee.
- 3. Request for Notice of Project Complete Letter: This request by the Permittee to the Colorado River Basin Water Board staff pertains to projects that either have completed post-construction monitoring and achieved performance standards or have no post-construction monitoring requirements, and no further Project activities are planned. - 4. <u>Post-Discharge Monitoring Period:</u> The post-discharge monitoring period begins on the date of the Notice of Completion of Discharges Letter and ends on the date of the Notice of Project Complete Letter issued by the Colorado River Basin Water Board staff. The Post-Discharge Monitoring Period includes continued water quality monitoring or compensatory mitigation monitoring.
- 5. Effective Date: Date of Order issuance.
