### **Notice of Public Workshop for a Review of Provisions to Incorporate Big Bear Lake Nutrient Total Maximum Daily Loads (TMDLs) into the Water Quality Control Plan for the Santa Ana River Basin (Basin Plan)**

Notice is hereby given that the California Regional Water Quality Control Board, Santa Ana Region (Regional Board) will conduct a public workshop to consider amendments to the Water Quality Control Plan (Basin Plan). The public workshop will be held at the regularly scheduled Regional Board Meeting on August 26, 2005 at the following time and location:

#### **Discussion**

Pursuant to Clean Water Act Section 303(d) the Regional Board has identified Big Bear Lake in the Big Bear Lake watershed as a water quality limited segment, that is, applicable water quality standards (beneficial uses and water quality objectives) are not being attained or are not expected to be attained with the implementation of technology-based controls. Impairment of this waterbody is due to elevated levels of nutrients and the presence of noxious aquatic plants.

To address the impairment, the Regional Board is required to develop Total Maximum Daily Load (TMDLs) for nutrients that will ensure attainment of water quality standards. Regional Board staff has prepared the draft Big Bear Lake Nutrient TMDLs that will be presented and discussed at the workshop. The report recommends amendments to the Basin Plan to incorporate the Nutrient TMDLs, an implementation plan, and a schedule for implementation and re-evaluation of the TMDLs.

The staff report and related documents may also be reviewed at the Regional Board office located at 3737 Main Street, Suite 500, Riverside, California, by appointment scheduled between Monday through Friday. Public participation is an important part of this process. The purpose of the public workshop is to receive testimony on the proposed Big Bear Lake Nutrient TMDLs and Basin Plan amendment. No formal action will occur at the August 26, 2005 workshop. Regional Board consideration of adoption of a proposed Basin Plan amendment will occur at a subsequent public hearing. The Regional Board will accept written and oral testimony at or prior to the August 26, 2005 workshop. We will also accept written comments up to September 2, 2005.
