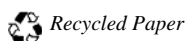

You are being sent this notification regarding the status of tentative Addendum No. 6 to Order No. 97-11 because you are either identified as a discharger responsible for the facility, or the Regional Board has your name on an Interested Parties List for Order No. 97-11.

This tentative Addendum was scheduled for consideration by the San Diego Regional Water Quality Control Board on August 8, 2007. However, since there was not a quorum, the tentative Addendum will be considered on **September 12, 2007**. Written comments on the tentative Addendum are due to the Regional Board on or before August 29, 2007.
